Applications are invited online only from qualified candidates belonging to reservation group of communities of Kerala State for appointment in the under mentioned post. Application must be submitted online through the Official website of the Commission after One Time Registration. Candidates who have already registered can apply through the profile.

- (i) Applications submitted by candidates belonging to the communities other than those notified will be summarily rejected. No rejection memo will be issued to these candidates.
 - (ii) Separate Ranked Lists will be prepared for above Districts (Kottayam & Kasargod) in pursuance of this notification. Ranked List thus prepared and published by the Commission shall remain in force until candidates are advised and appointed against the vacancies earmarked for the above community, but remain unfilled due to paucity of candidates during the currency of the Ranked List published for the post in the following dates in following districts.

- (iii) The candidates belonging to above reservation community shall submit application for this post to the district where the vacancy is in existence for their community and shall note the name of that district against the relevant column in the online application.
- (iv) The selection in pursuance of this notification will be made on a Revenue District basis, subject to the special conditions laid down in G O (MS) No. 154/71/PD dated 27.05.1971. A candidate advised for appointment in one Revenue District from the Ranked List prepared is not eligible for transfer to another district unless he/she completes five years continuous service from the date of commencement of service in the former district. Even if transfer is allowed after five years, it will be subject to the rules in G O (MS) No.4/61/PD, dated 2.1.1961. Candidates already in

Government Service holding the same post in any one district are prohibited from applying again for this post, but they can apply to higher posts when notified.

5. **Method of appointment** :- Direct Recruitment (From candidates belonging to SC and Muslim communities only)

Note : In the absence of Scheduled Caste candidates Scheduled Tribe candidates will also be considered.

6. **Age Limit** : SC. 18-41. Only candidates born between 2.1.1973 and 1.1.1996 (both dates included) are eligible to apply for this post.
- : Muslim. 18-39. Only candidates born between 2.1.1975 and 1.1.1996 (both dates included) are eligible to apply for this post.
(Including the relaxation as per para 2(i) of the General Conditions).

Note :- For concessions allowed in upper age limit, subject to the condition that the maximum age limit shall in no case exceed 50 years, please see para 2 of General Conditions under Part II of this notification except para 2 (i).

7. **Qualifications:-**

- (i) Pass in S.S.L.C or equivalent qualification
- (ii) A pass Certificate obtained after successful completion of General Nursing and Midwifery (GNM) Course conducted by the Government of Kerala or equivalent qualification recognized by the Government.

Candidates possessing this qualification shall undergo 3 months training in the pharmacy of any Hospital under Dept of Homoeopathy during the period of probation.

Note: KS&SSR Part II Rule 10 a (ii) is applicable for selection to this post.

8. Last date of receipt of applications : **04/02/2015** Wednesday upto 12 midnight.

9. Mode of submitting Applications :-

Candidates must register as per “ ONE TIME REGISTRATION” with the Official Website of Kerala Public Service Commission 'www.keralapsc.gov.in' before applying for the post. Candidates who have registered can apply by logging on to the 'Apply Now' button of the respective posts in the Notification Link to apply for a post. No application fee is required. Candidates can view and have a printout of the details on the registration card by clicking the link **Registration Card** after entering the home page. Candidates are responsible for the correctness of the personal information and secrecy of password. Before the final submission of the application on the profile, candidates must ensure the correctness of the information on their profile. They must quote their User Id for further communication with the Commission. Application submitted is provisional and cannot be deleted or altered on after submission. The application will be summarily rejected if non compliance with the notification is found in due course of processing. Documents to prove Qualification, experience, Community, age etc. have to be produced as and when called for.

10. If Written Test/OMR Test is conducted as a part of the selection Admission Tickets of eligible

candidates will be made available in the website of Kerala Public Service Commission. Candidates are instructed to download their Admission tickets as per the instructions given in the website.
