Applications are invited online only by **ONE TIME REGISTRATION** from qualified candidates belonging to PH (Locomotor disability/Cerebral palsy, Hearing impairment and Low vision) category for the following post in Kerala Government Service.

- 2. Name of post : Assistant Professor in Nursing**
- 3. Scale of pay : As per UGC Norms**
- 4. No. of vacancy : 2 (Two)**

The Ranked List prepared in response to this notification is intended to make recruitment to the backlog vacancies earmarked for the various categories and PH groups found eligible as per GO (P) No 61/12/SWD dated 17/10/2012 and will remain in force for a maximum period of three years subject to the condition that the ranked list will cease to exist as and when candidates are advised and appointed against the above mentioned vacancies. Rules 14 to 17 of Part II, KS&SSR are not applicable to this selection.

- 5. Method of Recruitment : Direct Recruitment**

**Note:-** Application submitted by candidates other than those belonging to PH (Locomotor disability/Cerebral palsy, Hearing impairment and Low vision) category will be rejected. Individual rejection memo will not be sent to them.

- 6. Age : 22 – 50. Candidates born between 02.01.1964 and 01.01.1992 (both dates included) are eligible to apply for this post. (including relaxations mentioned in Para 2 of the General Conditions)**
- 7. Qualification :**
  - (i) M.Sc Degree in Nursing from any University which is recognised by Kerala Nursing Council or Indian Nursing Council
  - (ii) Permanent Registration with Nursing Council (Those who have not registered with Kerala Nursing Council are also eligible provided they obtain registration with the Kerala Nursing Council before appointment)

**Note:-** Rule 10 (a)ii of Part II of the KS&SSR is applicable.

## **8 Method of submitting application**

Candidates must register as per 'ONE TIME REGISTRATION ' scheme through the Official Website of Kerala Public Service Commission '[www.keralapsc.gov.in](http://www.keralapsc.gov.in)' for applying to the post. Candidates who have already registered can apply by logging on to their profile using their User- ID and password. Candidates must click on the '**Apply Now**' button of the respective posts in the Notification link to apply for a post. No application fee is required. Candidates can view and have a printout of the details in the profile by clicking the link **Registration Card**. Candidates are responsible for the correctness of the personal information and secrecy of password. Before the final submission of the application, candidates must ensure correctness of the information on their profile. They must quote the User- ID for further communication with the Commission. Application submitted is provisional and cannot be deleted or altered after submission. The application will be summarily rejected if noncompliance with the provisions of the notification is found in due course of processing. Documents to prove Qualification, experience, community, age etc. have to be produced as and when called for.
