Applications once submitted will be received as provisional and particulars shall not be deleted or altered after submission. Applications submitted not in accordance with the conditions of the notification will be summarily rejected. Documents to prove Qualification, community, age etc. have to be produced as and when called for.

Note: - Candidates who secure not less than 40% marks in the test for by transfer recruitment alone will be eligible to be included in the Ranked list for recruitment by transfer. In the case of candidates included in the ranked list prepared for recruitment by transfer who could not secure appointment before the expiry of the ranked list the names of such candidates will be included in the new ranked list meant for by transfer appointment drawn up by the commission.
