5. Method of Appointment : Direct Recruitment (from Scheduled Tribes of Kerala State only).

Note: - Applications received from candidates other than ST will be rejected. Individual communications regarding the rejection of their applications for the above reason will not be Issued.

6. Age Limit: 18 – 41, only candidates born between 02.01.1972 and 01.01.1995 (both dates included) are eligible to apply for this post.

Note: - In the absence of qualified candidates within the age limit, the upper age limit shall be relaxed upto 50 years. But in no case the maximum age limit shall exceed 50 (Fifty) years.

7. Qualifications: (i) A pass in SSLC or equivalent.

(ii) Diploma in Fine Arts in Applied Arts awarded by Government of Kerala after regular

institutional course of study in Fine Arts institutions in Kerala or similar Government recognized institutions.
