If applications are submitted contrary to the above direction and if he/she is selected his/her name will be removed from the ranked list and disciplinary action will be taken against him/her.
  - (vi) The selection in pursuance of this notification will be made on a Revenue District basis, subject to the special conditions laid down in G.O. (MS) No. 154/71/PD dated 27.05.1971.
