Applications are invited Online only from qualified candidates for appointment in the undermentioned post in Kerala Government Service. Before applying for the post candidates should register as per One Time Registration through the official website of Kerala Public Service Commission

<b>1. Department</b>	<b>: Irrigation</b>
<b>2. Name of Post</b>	<b>: Dredger Cleaner</b>
<b>3. Scale of pay</b>	<b>: ₹ 16500 - 35700</b>
<b>4. Number of vacancies</b>	<b>: 4(Four)</b>

The above vacancies are now in existence. The list of selected candidates published by the Commission in response to this notification shall remain in force for a minimum period of one year provided that the said list will continue to be in force till the publication of a new list after the expiry of the minimum period of one year or till the expiry of three years whichever is earlier. Candidates will be advised from the said list against the vacancies noted above and that may be reported to the Commission in writing during the period of currency of the list.

**5 Method of appointment** : Direct Recruitment

**6 Age limit** : 20 -36, only candidates born between 02/01/1983 and 01/01/1999 (both dates included) are eligible to apply for the post with usual age relaxation to Scheduled Castes , Scheduled Tribes and other Backward Communities.

(for other conditions regarding age relaxation please see Para 2 of the General Conditions)

**7 Qualifications** : National Trade Certificate in the trade of Mechanic(Diesel)/  
Mechanic (Motor Vehicles)

**Note I** Rule 10(a) (ii) of Part II of KS & SSR is applicable.

**Note II** Applications of candidates who have claimed qualifications equivalent to those prescribed in the Gazette Notification for the post will be considered equivalent only if they produce Government Order to prove equivalency at the time of verification.

**Note III** If there is a difference in original Caste/Community claimed in the application and that entered in SSLC Book, the candidates shall produce a gazette notification in this regard, along with Non-Creamy Layer Certificate/ Community Certificate at the time of certificate verification

**8. Mode of submitting applications:-**

a) Candidates must register as per “ONE TIME REGISTRATION” with the official Website of Kerala Public Service Commission ‘[www.keralapsc.gov.in](http://www.keralapsc.gov.in)’ before applying for the post. Candidates who have registered can apply by logging on to their profile using their User -ID and password. Candidates must click on the Apply Now button of the respective posts in the Notification Link to apply for the post. The Photograph uploaded should be taken after 31.12.2010 . Name of the candidate and the date of taking photograph should be printed legibly at the bottom portion. The photograph once uploaded meeting all requirements shall be valid for 10 years from the date of uploading. There is no change in other instructions regarding the uploading of photographs. No application fee is required. Candidates shall take a printout of the application by clicking the link Registration Card in their profile. Candidates are responsible for the correctness of the personal information and secrecy of password. Before the final submission of the application on the profile candidates must ensure correctness of the information on their profile. They must quote the user ID for further communication with the Commission. Application once submitted is received as

provisional and the details cannot be deleted or altered after submission. The application will be summarily rejected if noncompliance with the notification is found in due course of processing . Documents to prove qualification, age, community etc. have to be produced as and when called for.

b) If Written/OMR/Online Test is conducted as part of this selection, candidates shall submit a confirmation for writing the examination through their One Time Registration profiles. Such candidates alone can generate and download the Admission Tickets in the last 15 days till the date of Test. The applications of candidates who do not submit confirmation within the stipulated period will be rejected summarily. The periods regarding the submission of confirmation and the availability of Admission Tickets will be published in the examination calendar itself. Information in this regard will be given to the candidates in their respective profiles and in the mobile phone number registered in it.

c) Candidates who have AADHAAR card should add AADHAAR Card as I.D Proof in their profile.
