Note:- The above vacancy is now in existence. The Ranked list published as per this notification will be valid until candidates are advised and appointed against the vacancies earmarked to the above community but remains unfilled due to the paucity of candidates during the currency of the Ranked list published on 07.12.2009 for the post. This is the eighth NCA notification for the post owing to non availability of qualified candidates belonging to the above community as per the First NCA notification (Gazette Date 31/12/2010 Category No.491/10), Second NCA notification (Gazette Date 28/12/2011 Category No.461/11), Third NCA notification (Gazette Date 30/04/2013 Category No.108/13), Fourth NCA notification(Gazette Date 12/08/2014 Category No.361/14), Fifth NCA notification (Gazette Date 29/12/2015 Category No. 563/15), Sixth NCA notification(Gazette Date 30/12/2016 Category No.474/16), Seventh NCA notification (Gazette Date 31/10/2017 Category No.424/17)

- 5. Method of appointment : Direct Recruitment -** from candidates belonging to the reservation group mentioned in this notification.(But applications of SC candidates will be considered in the absence of ST candidates).

NOTE: Applications of candidates belonging to community other than that mentioned in this notification will be summarily rejected. Individual rejection memo will not be sent to them.

- 6. Age : 22-45.** Only candidates born between 02.01.1974 and 01.01.1997 (both dates included) are eligible to apply.

[For other conditions regarding age relaxations,please see Para 2 of the General Conditions of the Gazette notifications, excluding para 2(i)]

7. Qualifications

1. Masters Degree in the concerned Subject with at least 50% marks or its equivalent and good academic record .
2. Must have passed a Comprehensive Test in the concerned subject specifically conducted for the purpose by UGC or any agency duly constituted by the state government in this behalf. When qualifications are equal, preference shall be given to candidates who possess adequate knowledge in Malayalam.

Note:(i) Candidates who have obtained Ph.D Degree in the concerned subject are exempted from passing the NET examination

- (ii) For recruitment to various posts under these rules, Degrees awarded by the Universities recognized by UGC alone shall be considered.
- (iii) KS & SSR Part II Rule 10(a)(ii) is applicable.
- (iv) Candidates who claim equivalent qualification instead of qualification mentioned in the notification shall produce the relevant Government Order to prove the equivalency at the time of verification, then only such qualification shall be treated as equivalent to the prescribed qualification concerned.
- (v) In the case of difference in original caste/community claimed in the application and that entered in SSLC book , the candidate shall produce a Gazette notification in this regard, along with Non Creamy Layer Certificate /Community Certificate at the time of certificate verification.

8. Mode of submitting Applications:-

a) Candidates must register as per 'ONE TIME REGISTRATION' with the official Website of Kerala Public Service Commission ie, www.keralapsc.gov.in before applying for the post. Candidates who have registered can apply by logging on to their profile using their User-ID and password. Candidates must click on the 'Apply Now' button of the respective post in the Notification Link to apply for the post. The Photograph uploaded should be taken after 31/12/2010. Name of the candidate and the date of photograph taken should be printed legibly at the bottom portion of the photograph. The photograph once uploaded, meeting all requirements, shall be valid for 10 years from the date of uploading. There is no change in other instructions regarding the uploading of photographs. No application fee is required. Candidates shall take a printout of the application by clicking the link 'Registration Card' in their profile. Candidates are responsible for the correctness of the personal information and secrecy of password. Before the final submission of the application on the profile, candidates must ensure correctness of the information in their profile. They must quote the User-ID for further communication with the Commission. Application submitted is provisional and cannot be deleted or altered after submission. The application will be summarily rejected if non-compliance with the notification is found in due course of processing. Documents to prove qualification, age, community etc have to be produced as and when called for.

b) Candidates who have AADHAAR card should add AADHAAR card as I.D. Proof in their profile.

9). If Written/OMR/Online Test is conducted as part of this selection, candidates shall submit a confirmation for writing the examination through their One Time Registration Profile. Such candidates alone can generate and download the Admission Tickets in the last 15 days till the date of test. The applications of candidates who do not submit confirmation within the stipulated period, will be rejected absolutely. The periods regarding the submission of confirmation and the availability of Admission Tickets will be published in the Examination Calendar itself. Information in this regard will be given to the candidates in their respective profiles and in the mobile phone number registered in it.
