This is the Sixth NCA Notification for the post owing to the non availability of qualified candidates belonging to the above community as per the first NCA Notification (Gazette date: 31.12.2010, Cat. No. 494/2010), Second NCA Notification (Gazette date: 16.07.2012, Cat. No. 388/2012), Third NCA Notification (Gazette date: 26.12.2014, Cat. No. 596/2014), Fourth NCA Notification (Gazette date: 26.07.2016, Cat. No. 205/2016) and Fifth NCA Notification (Gazette date: 30.05.17, Cat. No. 158/2017).

- 1. Masters Degree in the concerned Subject with at least 50% marks or its equivalent and good academic record.
- 2. Must have passed a Comprehensive Test in the concerned subject specifically conducted for the purpose by UGC or any agency duly constituted by the state government in this behalf. When qualifications are being equal, preference shall be given to those candidates who possess adequate knowledge in Malayalam.

Note: (i) Candidates who have obtained Ph.D Degree in the concerned subject are exempted from passing the NET examination

The photograph once uploaded meeting all requirements shall be valid for 10 years from the date of uploading. There is no change in other instructions regarding the uploading of photographs. No application fee is required. Candidates shall take a printout of the application by clicking the link 'Registration Card' in their profile. Candidates are responsible for the correctness of the personal information and secrecy of password. Before the final submission of the application on the profile, candidates must ensure correctness of the information in their profile. They must quote the User-ID for further communication with the Commission. Application submitted is provisional and cannot be deleted or altered after submission.
