The above vacancies are now in existence. The Ranked list published by the Commission in response to this notification shall remain in force for a minimum period of one year provided that the said list will continue to be in force till the publication of a new list after the expiry of the minimum period of one year or till the expiry of three years whichever is earlier. Candidates will be advised from the said list against the vacancies reported to the Commission in writing during the period of currency of the list.

Note:- 3% of vacancies for the post shall be reserved for differently abled candidates with Locomotor Disability/Cerebral palsy, Low Vision as per G.O.(P)No.61/2012/SWD dated.17.10.2012. As per G.O. (P) differently abled candidates with other disabilities are not eligible to apply for this post.

6 Age limit : 20-39. (Only candidates born between 02.01.1980 and

01.01.1999(both dates included) are eligible to apply for this post with usual relaxation to Scheduled Castes, Scheduled Tribes, other

Backward communities.(For other conditions regarding the age

relaxation please see para (2) of the General Conditions)

Note: Officers of the Technical Education Department, Public Works Department, Public Health Engineering Department, Industries Department, Architecture and Town Planning

Department may also apply. They will be allowed age relaxation

to the extent of their service in those departments. (Maximum age limit shall not exceed 50 years as on 01.01.2019.

7 **Qualifications** First class Masters Degree in Commerce from a recognized University after undergoing a regular course of study and Diploma in Commercial Practice.

Note : 1. Rule 10(a)(ii) of Part II KS&SSR is applicable.

- 2. Those who claim equivalent qualifications mentioned in the notification shall produce for the relevant government Order to prove the equivalency at the time of verification, then only such qualification shall be treated as equivalent to the prescribed qualification concerned.
- 3. In the case of difference in original Caste/Community claimed in the application and that entered in S.S.L.C book, the candidate shall produce a Gazette Notification in this regard, along with Non Creamy Layer Certificate/Community Certificate at the time of Certificate Verification.

<u>Liability to serving defence services</u>:- Persons appointed to the post requiring engineering graduates shall be liable, not withstanding that at the time of requisition they are holding higher appointments, to serve for a minimum period of 4 years (including period spend in training) in the Defence Services or on assignment relating to defence efforts anywhere in India or abroad, if so required. The liability to serve in the Defence Services will be limited to the first 10 years of service and will not ordinarily apply to persons above 40 years of age.

Candidates who have registered can apply by logging on to their profile using their User-ID and password. Candidates must click on the 'Apply Now' button of the respective posts in the Notification Link to apply for a post. The Photograph uploaded should be taken after 31.12.2010. Name of the candidate and the date of photograph taken should be printed legibly at the bottom portion. The photograph once uploaded meeting all requirements shall be valid

for 10 years from the date of uploading. There is no change in other instructions regarding the uploading of photographs. No application fee is required. Candidates shall take a printout of the application by clicking the link **Registration Card** in their profile. Candidates are responsible for the correctness of the personal information and secrecy of password. Before the final submission of the application on the profile candidates must ensure correctness of the information in their profile. They must quote the User-ID for further communication with the Commission. Application submitted is provisional and cannot be deleted or altered after submission. The application will be summarily rejected if noncompliance with the notification is found in due course of processing. Documents to prove qualification, age, Community etc. have to be produced as and when called for.

- **(b)** Candidates who have AADHAAR card should add AADHAAR Card as I.D Proof in their profile.
- (c) If written OMR/Online Test as part of this selection candidates shall submit a confirmation for writing the examination through their One Time Registration Profile. Such candidates alone can generate and download the Admission Tickets in the last 15 days till the date of Test. The applications of candidates who do not submit conformation within the stipulated period, will be rejected absolutely. The periods regarding the submission of conformation and the availability of Admission Tickets will be published in the Examination Calendar itself.
