Applications are invited from qualified candidates belonging to Muslim & SCCC (Scheduled caste converted to Christianity) Communities of Kerala State for appointment to the under mentioned post. Application must be submitted online through the Official website of the Commission after One Time Registration. Candidates who have already registered can apply through their profile.

Note: (I) Applications submitted by candidates belonging to the communities other than those notified will be summarily rejected. No rejection memo will be issued to these candidates.

(ii) A Ranked List will be prepared for the above districts in pursuance of this notification for the above communities. Ranked Lists thus prepared and published by the Commission shall remain in force until candidates are advised and appointed against the vacancies earmarked for the above community, but remain unfilled due to paucity of candidates during the currency of the Ranked List published for the post in the following districts or for three years from the date of publication of the NCA Ranked List as per this notification whichever is earlier.

- (iii) This is the NCA notification for the post owing to non-availability of qualified candidates belonging to the above communities. The Candidates belonging to above reservation communities shall submit application for this post to the district where the vacancy is in existence for their community and shall note the name of that district against the relevant column of the Online application.
- (iv) If the community claim in the application differs from the community noted in SSLC, then such changes are to be published in the gazette on or before the date of verification of original documents and the same should be produced along with the Community Certificate/Non creamy layer certificate issued by the Revenue authorities at the time of One Time Verification or as and when required by the commission.
- (v) The selection in pursuance of this notification will be made on a Revenue District basis, subject to the special conditions laid down in G.O (MS) No. 154/71/PD dated 27.05.1971. A candidate advised for appointment in one Revenue District from the Ranked List prepared is not eligible for transfer to another district unless he/she completes five years continuous service from the date of commencement of service in the former district. Even if transfer is allowed after five years, it will be subject to the rules in G O (P) No. 36/91/P&ARD, dated 2.12.1991.
- Candidates already in Government Service holding the same post in any one district are prohibited from applying again for this post, but they can apply to higher posts when notified.

5. Method of appointment:- Direct Recruitment (From candidates belonging to **Muslim & Scheduled caste converted to Christianity Only**).
6. **Age Limit** :- **18-39** only candidates born between 02.01.1980 & 01.01.2001 (both dates included) are eligible to apply for this post. [This includes the **Muslim** relaxation as per Para 2(i) of General Conditions].

**18-41** only candidates born between 02.01.1978 & 01.01.2001 (both dates included) are eligible to apply for the post. (This includes the relaxation as per para 2(1)of General Conditions).

*Note: 1) Adult members belonging to any of the Scheduled Caste who had converted to Christianity and children of such parents are also eligible to apply for this post. Those candidates should be born between 02.01.1978 and 01.01.2001 (both dates included). (The relaxation as per Para 2(i) of general conditions are concerned).*

*2) For concessions allowed in upper age limit, subject to the condition that the maximum age limit shall in no case exceed 50 years, please see para (2) of the General Conditions under Part II of this Notification.*

**7 Qualifications:-**

1. Pass in S.S.L.C
2. (A) Surveying and Levelling (Lower) KGTE/MGTE and pass in any two of the following qualifications of KGTE/MGTE (Lower)
  - (a) Building Drawing and Estimating (Lower)
  - (b) Building materials and construction (Lower)
  - (c) Earth work and Road making (Lower)
  - (d) Hydraulics and Irrigation Engineering (Lower)
  - (e) Mensuration (Lower)

**OR**

- (B) Certificate issued by the Director General of Resettlement and Employment in Surveyor Trade under the Craftsman Training Scheme.

**OR**

- (C) ITI Draftsman Certificate in Civil/Mechanical

**OR**

- (D) Diploma in Agricultural and Rural Engineering awarded by the Kerala Agricultural University or its equivalent recognized by the Kerala Agricultural University with a period not less than 2 years.

*Note :- 1. KS&SSR Part II Rule 10 (a) (ii) is applicable for selection to this post.*

*2. Candidates claiming equivalent qualification should produce relevant Government Orders during OTR verification to prove that the qualification claimed is equivalent to the prescribed qualification for the Post.*

8. Mode of submitting Applications :-

Candidates must register as per ONE TIME REGISTRATION scheme through the Official Website of Kerala Public Service Commission [www.keralapsc.gov.in](http://www.keralapsc.gov.in) before applying for the post. Candidates who have already registered can apply by logging in to their profile using their User-ID and password. Candidates must click on the Apply Now button of the respective posts in the Notification Link to apply for a post. The photograph uploaded should be one taken on or after 31/12/2010. Name of the candidate and the date of taking photograph should be printed at the bottom portion. The photograph once uploaded meeting all requirements shall be valid for 10 years from the date of taking the photograph. There is no change in other instructions regarding the uploading of photographs. No application fee is required. Candidates shall take a printout of the application by clicking the link Registration Card in their profile. Candidates are responsible for the correctness of the personal information and secrecy of password. Before the final submission of application on the profile, candidates must ensure the correctness of the information on their profile. They must quote their User-ID for further communication with the Commission. Application submitted is provisional and cannot be deleted or altered after submission. The Application will be summarily rejected if noncompliance with the notification is found in due course of processing. Documents to prove Qualification, Experience, Community, age etc. have to be produced as and when called for. **Candidates who have Aadhar Card should add Aadhar Card as ID proof in their profile.**

9. Last date of receipt of applications : **29/08/2019** Thursday upto 12 midnight.

10. If Written Test/OMR/Online Test is conducted as part of this selection, candidates shall submit a confirmation for writing the examination through their One Time Registration profile. Such candidates alone can generate and download the Admission Tickets in the last 15 days till the date of Test. The applications of candidates who do not submit confirmation within the stipulated period will be rejected absolutely. The periods regarding the submission of confirmation and the availability of Admission Tickets will be published in the Examination Calendar itself. Information in this regard will be given to the candidates in their respective profiles and in the mobile phones registered in it. Candidates who have downloaded the Admission Ticket will alone be permitted to attend the examination.
