Candidates who wish to obtain a photocopy of their OMR answer sheet (Part A & Part B) relating to this selection shall remit a fee of Rs.315/-(Rupees Three hundred and Fifteen only) by way of chalan in any of the Treasuries in the State under the Head of Account 0051-PSC-800-State PSC -99 Other receipts. The duly filled up application in the prescribed form (available from the Commission's Website www. keralapsc.gov.in) along with the original chalan should be submitted to the District Officer, KPSC District Office, Palakkad within 45 days from the date on which the Ranked List has come in to force. A copy of the answer sheet will be issued only once to a candidate. Candidates are prohibited from applying for a copy of answer sheet which is not their own, and legal proceedings will be initiated against those who do so.
