NOTIFICATION

The following list contains the name of candidates who are found suitable on the basis of the result of the Objective Type Test (OMR Valuation) Test held on **19.05.2018**, and verification of original documents that followed for selection to the post of **AYAH (NCA-MUSLIM) (CATEGORY NO: 60/2017)** on **Rs.16500-35700/- in VARIOUS DEPARTMENT in THRISSUR DISTRICT** arranged in the order of merit. Since a Common Objective Type (OMR Valuation) Test was held for this post, the marks awarded to the candidates included in the Ranked List and marks of OMR test relating to all candidates appeared for the test will be published only after the publication of entire Ranked List (including NCA Notifications) which will be finalised on the basis of the common test.

The Ranked List is brought into force with effect from 03/10/2019. The Ranked List will remain in force until candidates are advised and appointed against the NCA vacancies notified for Muslim Community but remain unfilled due to the paucity of candidates during the currency of the Ranked List published for the post on 20.10.2016 in Thrissur District as Category No:24/2014 for the above post. As the advice for appointment depends on the occurrence of vacancies, there is no guarantee that all candidates included in this list will secure appointment. The candidates remaining in the list at the time of cancellation will have no claim at all for appointment on the basis of the inclusion of their names in the list.

According to the existing procedure, re-valuation of Answer Script is not allowed. But answer scripts will be rechecked if prescribed fee of Rs.**85/-** (Rupees Eighty Five only) is remitted in any one of the Treasuries in the State by chalan under the Head of Account **"0051 PSC-105 STATE PSC-99 EXAMINATION FEE"**. Applications for rechecking of answer scripts should be submitted in the prescribed form available free of cost from the enquiry sections of the various offices of the Commission or its photocopy or downloaded and printed in A4 size paper from the Commission's website:www.keralapsc.gov.in or photocopied there from. The original chalan receipt for the prescribed fee should be produced with the application for re-

checking. Applications submitted in any other manner will not be considered.

Candidates who wish to obtain a Photocopy of their OMR answer sheet (Part A and Part B) relating to this selection shall remit a fee of **Rs.335/-** (Rupees Three Hundred and Thirty Five only) by way of chalan in any of the Treasuries in the State under Head of Account “**0051-PSC-800 STATE PSC-99 OTHER RECEIPTS**”). The duly filled up application in the prescribed form (available from the commission's website: www.keralapsc.gov.in) along with the original chalan should be submitted to **The District Officer, Kerala Public Service Commission District Office, Thrissur within 45 days from the date on which the Ranked List is brought into force.** A copy of an answer sheet will be issued only once to a candidate. Candidates are prohibited from applying for a copy of an answer sheet which is not their own, and legal proceedings will be initiated against those who do so.

Valid applications for re-checking/obtaining photocopy of answer script along with original chalan receipts addressed to the **District Officer, Kerala Public Service Commission District Office, Thrissur** shall reach this office within 45 days from the date on which the Ranked List has come into force (i.e. the date on which the Ranked List has been approved by the commission). The last date for receipt of applications for rechecking/obtaining photocopy of the answer script is **16/11/2019.**

Applications for rechecking/obtaining photocopy received after the prescribed time limit or not in the prescribed form or not with the original chalan receipt for prescribed fee will not entrained. The fee once remitted will not be refunded on any account. In the case of candidates who sem application for rechecking in the prescribed form within the prescribed time limit enclosing original chalan receipt as stated above, the marks awarded will be rechecked and the result of the rechecking will be intimated to the candidates from this office.

The result of re-checking of OMR scripts will be intimated in due course. But photo copy of the OMR answer scripts will be issued only after the publication of the Ranked List for the post finalised on the basis of the common test .

“Any candidate can relinquish his/her right for appointment in writing duly attested by a Gazetted Officer of State/Central Government with signature, Name, Designation and Office Seal, along with an affidavit from NOTARY PUBLIC and self attested copy of ID proof bearing photograph as enlisted in the General Conditions. The request for relinquishment received within 15 days from the date of publication of the Ranked List in the Official website of the Commission will be honoured against the requisitions of vacancies that are pending with the

Ayah (NCA-Muslim) in Various Dept. in Thrissur Dist.

Commission upto the finalisation of the Ranked List. After the publication of the Ranked List, the request for relinquishment will be considered only if such request is received on or before the date of receipt of requisition, based on which he/she is to be advised”.
