**NOTIFICATION**

The following is the Ranked list of candidates for the post of **Driver -Cum-Office Attendant (LDV) (1st NCA- Viswakarma) (Category No. 155/2016)** in **Various Departments** in **Pathanamthitta District** on **₹.9190-15780/-** notified in the Gazette dated **14/06/2016** and found suitable by the Commission and arranged in the order of merit based on the marks secured in OMR Test held on **28/01/2017** followed by Practical Test and OTV. The Ranked List is brought into force with effect from **03/10/2019**.

This NCA Ranked List brought in force with effect from 03/10/2019 and will be valid until the candidates are advised and appointed against the vacancies notified due to the paucity of candidates belonging to Viswakarma community during the currency of the Mother Ranked list (Cat No. 32/2007) published on 31/12/2010 or three years from the date of publication of this NCA ranked list whichever is earlier. As the advice for appointment depends on the occurrence of vacancies, there is no guarantee that all candidates included in the list will secure appointment. The candidates remaining in the list at the time of cancellation will have no claim at all for appointment on the basis of the inclusion of their names in the list.

According to the existing procedure, revaluation of Answer Script is not allowed. But answer scripts will be re-checked, to see that all the answers are valued and that there is no mistake in the totaling of marks for various answers, if the candidates apply for rechecking, remitting the prescribed fee of **₹ 85/-** (Rupees Eighty Five only) in any one of the Treasuries in the State under the Head of Account "**0051 PSC 105 State PSC 99 Examination Fee**". Applications for rechecking of answer scripts should be submitted in the prescribed form available free of cost from the enquiry sections of the various offices of the Commission or its photocopy or downloaded and printed in A4 size paper from the Commission's website/[www.keralapsc.gov.in](http://www.keralapsc.gov.in) / or photocopied therefrom. Applications submitted in any other manner will not be considered. The application for rechecking along with the original chalan receipt should reach the **District Officer, Kerala Public Service Commission District Office, Pathanamthitta within 45 days from the date on which the Ranked List has come into force** (i.e. the date on which the Ranked List has been approved by the Commission). Application for rechecking received after the prescribed time limit or not in the prescribed form will not be entertained. The fee once remitted will not be refunded on any account. In the case of candidates who sent applications for rechecking in prescribed form within the prescribed time limit enclosing original chalan receipt as stated above, the marks awarded will be rechecked and the result of the rechecking will be intimated to the candidates from this office. Applications for rechecking received from the candidates whose answer scripts have been invalidated will not be considered.

Candidates who wish to obtain a photocopy of their OMR answer sheet (Part A & Part B) relating to this selection shall remit a fee of ₹ 335/- (Rupees Three hundred and thirty five only) by way of chalan in any of the treasuries in the State under the Head of Account “0051 PSC-800 State PSC 99 other receipts”. The duly filled up application in the prescribed form (available in the commission’s website www.keralapsc.gov.in) along with the original chalan should be submitted to the District Officer, K.P.S.C District Office, Pathanamthitta within 45 days from the date on which the Ranked List has come into force. A copy of the answer sheet will be issued only once to a candidate. Candidates are prohibited from applying for a copy of answer sheet which is not their own, and legal proceedings will be initiated against those who do so.

Valid applications for rechecking/ photocopy of answer script addressed to the District Officer, K.P.S.C District Office, Pathanamthitta shall reach this office within 45 days from the date on which the Ranked List is brought into force. The last date for receipt of applications for rechecking/ photocopy of answer script is **16.11.2019**. Application for rechecking/ photocopy received after the prescribed time limit and not in the prescribed form will not be entertained. Photocopy of the OMR answer script will be issued only after the publication of the Ranked List for all the posts finalised on the basis of the common test.

Entries put in column 8 are based on the communities specified by the candidates in their profile proved by them with necessary documents. The candidates whose communities have not been correctly noted in the Ranked List as proved by them in their application (profile) should intimate the fact to the District Officer, Kerala Public Service Commission, District Office, Pathanamthitta within one month from the date of publication of the Ranked List to get the benefit of reservation to which they are entitled to. In the absence of timely information regarding discrepancies, if any, the candidates will be advised as incorporated in the list.

**“Any Candidate can relinquish his/her right for appointment in writing duly attested by a Gazetted Officer of State/Central Government with signature, name, designation and Office Seal, an Affidavit attested by Notary and a self attested copy of ID proof bearing photograph as enlisted in the general conditions. The request for relinquishment received within 15 days from the date of publication of Ranked List in the official website will be honoured against the requisitions of vacancies that are pending with the Commission up to the finalisation of ranked list. After the publication of the Ranked List, the request for relinquishment will be considered only if such request is received on or before the date of receipt of requisition, based on which he/she is to be advised.”**
