The names of low paid employees who secure 40% marks and above in the selective test conducted by the Public Service Commission and thus became qualified for appointment as Lower Division Typist, but could not secure appointment before expiry of the ranked list will be included at the top of the new separate ranked list of Low paid employees irrespective of their service and seniority and they will be given appointment accordingly.
