Applications are invited online only by One Time Registration from qualified candidates for the under mentioned post. Candidates shall apply only through the online facility provided in the website of Kerala Public Service Commission.

1. **Department** : **Port (Hydrographic Survey Wing)**
2. **Name of post** : **Cook**
3. **Scale of pay** : **Rs. 16500-35700/-**
4. **Number of vacancies** : **District wise**

- (i) Candidates shall apply online only by One Time Registration available at the Kerala Public Service Commission website viz www.keralapsc.gov.in
 - (ii) The above vacancy is now in existence. The Ranked List will be prepared for the above district in pursuance of this notification. The Ranked list thus prepared and published by the Commission, shall remain in force for a minimum period of one year and a maximum period of three years provided the said list will not continue to be in force if a new list is published after the expiry of the minimum period of one year. Candidates will be advised for appointment against the aforesaid vacancy and also against the vacancies, if any reported during the currency of the list. In case no candidate is advised from the ranked list till the expiry period of three years, the duration of the ranked list shall be extended for a further period of one year or till at least one candidate is advised from the list whichever is earlier.
 - (iii) The selection in pursuance of this notification will be made on a Revenue District basis, subject to the special conditions laid down in G O (MS) No.154/71/PD dated 27.05.1971. A candidate advised for appointment in one Revenue District from the Ranked List prepared is not eligible for transfer to another district unless he/she completes five years continuous service from the date of commencement of service in the former district. Even if transfer is allowed after five years, it will be subject to the rules in G.O.(Ms)No.4/61/PD dated 02.01.1961. Candidates already in Government Service holding the same post in any one district are prohibited from applying again for this post, but they can apply to higher posts when notified.
 - (iv) Candidates should submit the application for this post to any one of the above districts, where the vacancy is existing and should note the name of the concerned District against the relevant column of the online application.

Applications should not be submitted to more than one districts in response to this notification. If applications are submitted contrary to the above directions, and if he/she is selected his/her name will be removed from the ranked list and disciplinary action will be taken against him/her.

- (v) If there is any change in caste/community with respect to the entries in S.S.L.C, then such changes is to be published in the gazette notification and the same along with the Community Certificate/Non Creamy Layer Certificate issued by the Revenue Authorities, is to be produced to prove their claim in application, at the time of One Time Verification or as and when required by the Commission.

5. Method of appointment : Direct Recruitment.
6. Age Limit : 18-45. Candidates should have been born between 02.01.1974 and 01.01.2001 (both dates included) are eligible to apply for the post. Usual age relaxation will be given to SC/ST & Other backward Communities.

Note: (1) For concessions allowed in upper age limit, subject to the condition that the maximum age limit shall in no case exceed 50 years, please see para (2) of the General Conditions under Part II of this Notification.

7. Qualifications :

- 1) Literacy.
- 2) Must have worked on board a ship as a Cook or as a Camp Cook to Army or Air Force Unit or in Port Department. Must be able to Cook Cosmopolitan food as required by all communities comprising the Hydrographic Survey Wing.

Note 1:

Candidates should produce a certificate which state that “He/She (name and address) has served as camp cook in Army/Airforce/Port Department fromto.....and prove to the efficiency in preparing all types of food(including Cosmopolitan food also) for personnels including all sections in Hydrographic Survey Wing” and the certificate shall be duly certified by the concerned controlling officer and the same should be countersigned by the Head of the Office and to produce before the Commission as and when required.

Note 2:

- (i) Rule 10 a (ii) of Part II KS&SSR will be applicable for this post.
- (ii) Those who claim equivalent qualification shall produce the respective Government Order to prove the claim at the time of 'One Time Verification' or as required by the Commission.

8. Mode of submitting application:

Candidates must register as per ONE TIME REGISTRATION with the Official Website of Kerala Public Service Commission www.keralapsc.gov.in before applying for the post. Candidates who have registered can apply by logging in to their profile using their User-ID and password. Candidates must click on the Apply Now button of the respective posts in the Notification Link to applying for a post. The photograph uploaded should be one taken after

31/12/2010. Name of the candidate and the date of taking photograph should be printed at the bottom portion. The photograph once uploaded meeting all requirements shall be valid for 10 years from the date of taking of the photograph. There is no change in other instructions regarding the uploading of photographs. No application fee is required. Candidates shall take a printout of the application by clicking the link Registration Card in their profile. Candidates are responsible for the correctness of the personal information and secrecy of password. Before the final submission of the application on the profile, candidates must ensure the correctness of the information on their profile. They must quote their User-ID for further communication with the Commission. Application submitted is provisional and cannot be deleted or altered after submission. The application will be summarily rejected if noncompliance with the notification is found in due course of processing. Documents to prove Qualification, experience, Community, age etc. have to be produced as and when called for. Candidates who have AADHAAR Card should add AADHAAR Card as Identification Certificate proof in their profile.

11. If a Written Test/OMR/Online Examination is conducted as a part of this selection, candidates shall submit a confirmation for writing the examination through their One Time Registration profile. Such candidates alone can generate and download the Admission Tickets in the last 15 days till the date of test. The applications of candidates who do not submit confirmation within the stipulated period will be rejected absolutely. The periods regarding the submission of confirmation and the availability of Admission Tickets will be published in the Examination Calender itself. Information in this regard will be given to the candidates in their respective profiles and in the mobile phones registered in it. Appropriate disciplinary action as per Rule 22 of the Kerala Public Service Commission Rules of Procedure will be taken against those candidates who submit application for the post will false claims of possession of prescribed qualification, experience etc., and give confirmation for examination, irrespective of the fact that whether they have appeared or not for the examination.
