6 Age	:	18-50. Only candidates born between 02.01.1969 and 01.01.2001 (both dates included) are eligible to apply for this post.

- 7 Qualifications: 1 Must have 3 (three) years regular service in any cadre in the Member society affiliated to the Kerala Co-operative Milk Marketing Federation Limited and should be in service of the Member society not only on the date of application but also on the date of appointment to the new post.
  - 2 B.Com / BBA / BBM / B.Sc.(Co-op. And Banking) or any degree from a recognized University.
- Note: i) Rule 10 (a) (ii) of Part II KS&SSR is applicable for this selection.
  - ii) The requirement that the employees should be in service of the society on the date of appointment will not be applicable to those who were recruited through the PSC to a post in the Apex/Central Societies reserved for the employees of the affiliated Primary Co-operative/Member Societies, provided they are continuing in service in that post.
