- (ii) The Candidates belonging to above reservation community shall submit application for the post to Ernakulam District where the vacancy is existing and shall note the name of that district against the relevant column of the Online application.
- (iii) The Seventh NCA notification is issued due to the paucity of candidates belonging to above Community after the issuance of the First NCA notification vide Cat. No.160/09, the Second NCA notification vide Cat.No.166/11, the third NCA Notification vide Cat. No.743/12, the fourth NCA Notification vide Cat. No.53/2014, the fifth NCA Notification vide Cat. No. 463/15 and the sixth NCA notification vide Cat. No. 527/16.
- (iv) In case of change in Caste noted in the SSLC book, candidates must claim their original Caste in the application and shall produce Non-Creamy Layer Certificate issued by the Revenue Authorities and the original Gazette notification publishing the change of Caste/Community at the time of OTR verification for selection to the above post.
- (v) The selection in pursuance of this notification will be made on a Revenue District basis, subject to the special conditions laid down in G.O (MS) No. 154/71/PD dated 27.05.1971. A candidate advised for appointment in one Revenue District from the

Ranked List prepared is not eligible for transfer to another district unless he/she completes five years continuous service from the date of commencement of service in the former district. Even if transfer is allowed after five years, it will be subject to the rules in G O (MS) No.4/61/PD, dated 2.1.1961. Candidates already in Government Service holding the same post in the same department in any one district are prohibited from applying again for this post.

- 5. Method of appointment
 :- Direct Recruitment (From candidates belonging to LC community of Kerala State Only). Note: Application of candidates belonging to the community other than those belonging to LC Community will be summarily rejected. No rejection memo will be issued to these candidates.
- 6. Age Limit :- **18-39** Only candidates born between 02.01.1980 & 01.01.2001 (both dates included)are eligible to apply for this post. [Including the relaxation as per para 2 (i) of General Conditions].
 - Note:-For concessions allowed in upper age limit, subject to the condition that the maximum age limit shall in no case exceed 50 years, please see para (2) of the General Conditions under Part II of this Notification. [except para 2(i)].

7. Qualifications:-

- (i) Pass in S.S.L.C or its equivalent qualification.
- (ii) A pass Certificate obtained after successful completion of Nurse Cum Pharmacist Training Course (Homoeopathy) conducted by the Government of Kerala.

OR

A pass in Certificate Course in Pharmacy (Homoeo) recognised by the Government .

Note :- 1. KS&SSR Part II Rule 10 (a) (ii) is applicable for selection to this post.

- 2. Candidates claiming equivalent qualification should produce relevant Government Orders during OTR verification to prove that the qualification claimed is equivalent to the prescribed qualification for the Post.
- 8. Mode of submitting Applications :-

Candidates must register as per ONE TIME REGISTRATION scheme through the Official Website of Kerala Public Service Commission <u>www.keralapsc.gov.in</u> before applying for the post. Candidates who have already registered can apply by logging in to their profile using their User-ID and password. Candidates must click on the Apply Now button of the respective posts in the Notification Link to apply for a post. The photograph uploaded should be one taken on or after 31/12/2010. Name of the candidate and the date of taking photograph should be printed at the bottom portion. The photograph once uploaded meeting all requirements shall be valid for 10 years from the date of taking the photograph. There is no change in other instructions regarding the uploading of photographs. No application fee is required. Candidates shall take a printout of the application by clicking the link Registration Card in their profile. Candidates are responsible for the correctness of the personal information and secrecy of password. Before the final submission of application on the profile, candidates must ensure the

correctness of the information on their profile. They must quote their User-ID for further communication with the Commission. Application submitted is provisional and cannot be deleted or altered after submission. The Application will be summarily rejected if noncompliance with the notification is found in due course of processing. Documents to prove Qualification, Experience, Community, age etc. have to be produced as and when called for. **Candidates who have Aadhar Card should add Aadhar Card as ID proof in their profile.**

- 10. If Written Test/OMR/Online Test is conducted as part of this selection, candidates shall submit a confirmation for writing the examination through their One Time Registration profile.
