Candidates who claim equivalent qualification instead of qualification mentioned in the notification shall produce the relevant Government Order to prove the equivalency at the time of verification, then only such qualification shall be treated as equivalent to the prescribed qualification concerned.</li><li>3. (A)	Candidates must register as per "ONE TIME REGISTRATION" with the official Website of Kerala Public Service Commission ' <a href="http://www.keralapsc.gov.in">www.keralapsc.gov.in</a> ' before applying for the post. Candidates who have registered can apply by logging on to their profile using their User-ID and password. Candidates must click on the ' <b>Apply Now</b> ' button of the respective post in the Notification Link to apply for the post. The Photograph uploaded in the profile should be one taken after 31.12.2010. Name of the candidate and the date of taking photograph should be printed legibly at the bottom portion. The photograph once uploaded meeting all requirements shall be valid for 10 years from the		

	<p>date of uploading. There is no change in other instructions regarding the uploading of photographs. No application fee is required. Candidates shall take a printout of the application by clicking the link <b>Registration Card</b> on their profile. Candidates are responsible for the correctness of the personal information and secrecy of password. Before the final submission of the application on the profile, candidates must ensure correctness of the information on their profile. They must quote the User-ID for further communication with the Commission. Application once submitted is received as provisional and the details cannot be deleted or altered after the last date of receipt of applications. The applications submitted not in accordance with the conditions stipulated in the notification will be summarily rejected in due course of processing. Documents to prove qualification, Community, age etc. have to be produced as and when called for.</p>
(B)	<p>If a Written/OMR/Online Test is conducted as part of this selection, candidates shall submit a confirmation for writing the examination through their One Time Registration profile. Such candidates alone can generate and download the Admission Tickets in the last 15 days till the date of Test. The application of candidates who do not submit confirmation within the stipulated period, will be rejected absolutely,.
