Applications are invited only Online exclusively from qualified candidates belonging to Hindu Nadar Community of Kerala State for appointment in the undermentioned post in Kerala Government Service. Before applying for the post the candidates shall register as per One Time Registration scheme through the official website of Kerala Public Service Commission.

- 1. Department** : Kerala Dairy Development
- 2. Name of Post** : Dairy Extension Officer
- 3. Scale of Pay** : ₹ 39500 - 83000/-
- 4. Number of vacancies** : 01 (One) Hindu Nadar

The above vacancy is now in existence. The Ranked list published as per this notification will be valid until candidates are advised and appointed against the above vacancy earmarked for the above mentioned Community, but remain unfilled due to paucity of candidates during the currency of the ranked list published on 07.01.2016 (Cat.No.157/2013).

- 5. Method of appointment** : Direct Recruitment (From the candidates belong to Hindu Nadar community only).

Note :- Applications submitted by candidates belonging to communities other than Hindu Nadar community will be summarily rejected. Individual communication regarding the rejection of their application will not be issued.

- 6. Age limit** : 20-40. Only candidates born between 02.01.1979 and 01.01.1999 (both dates included) are eligible to apply for this post. (Including the relaxation as per para 2(i) of the General Conditions.) [For other conditions regarding age

relaxation, please see Para 2 of the General Conditions.
Except Para 2(i)]

- 7. Qualifications** : B.Sc in Dairy Science or B.Tech (Dairy Science and Technology) from a recognised University or National Dairy Research Institute under the Indian Council of Agricultural Research (ICAR).

Note:- (1) Rule 10(a) ii of Part II of KS & SSR is applicable.

(2) Candidates who claim equivalent qualification instead of qualification mentioned in the notification shall produce the relevant Government order to prove the equivalency at the time of verification, then only such qualification shall be treated as equivalent to the prescribed qualification concerned.

(3) In the case of difference in original caste/community claimed in the application and that entered in SSLC book, the candidate shall produce a Gazette notification in this regard, along with Non creamy layer Certificate/ community certificate at the time of certificate verification.

8 Mode of submitting Application:-

- (A) Candidates must register as per “ONE TIME REGISTRATION” with the official Website of Kerala Public Service Commission 'www.keralapsc.gov.in' before applying for the post. Candidates who have registered can apply by log in to their profile using their User-ID and password. Candidates must click on the 'Apply Now' button of the respective post in the Notification Link to apply for the post. The Photograph uploaded should be one taken after 31.12.2010. Name of the candidate and the date of taking photograph should be printed at the bottom portion. The photograph once uploaded meeting all requirements shall be valid for 10 years from the date of uploading. There is no change in other instructions regarding the uploading of photographs. No application fee is required. Candidates shall take a printout of the application by clicking the link Registration Card in their profile. Candidates are responsible for the correctness of the personal information and secrecy of password. Before the final submission of the application on the profile, candidates must ensure correctness of the information on their profile. Application once submitted is received as provisional and the details cannot be deleted or altered after submission. The applications will be summarily rejected if non compliance with the notification is found in due course of processing. Documents to prove qualification, Experience, Community, age etc. have to be produced as and when called for. Candidate must quote the User-ID for further communication with the Commission.
- (B) If Written/OMR/Online Test is conducted as part of this selection, candidates shall submit a confirmation for writing the examination through their One Time Registration profile. Such candidates alone can generate and download the Admission Tickets in the last 15 days till the date of Test. The applications of candidates who do not submit confirmation within the stipulated period, will be rejected absolutely. The periods regarding the submission of confirmation and the availability of Admission Tickets will be published in the Examination Calendar itself. Information in this regard will be given to the candidates in their respective

profiles and in the mobile phone number registered in it.

(C) “Candidates who have AADHAAR card should add AADHAAR card as I.D. Proof in their profile.”
