(i) this notification. The Ranked list thus prepared and published by the Commission, shall remain in force for a minimum period of one year, subject to the condition that the said list will continue to be in force till the publication of a new list after the expiry of the minimum period of one year or till the expiry of three years whichever is earlier. Candidates will be advised for appointment against the aforesaid vacancy and also against the vacancies, if any, reported during the currency of the list. In case no candidate is advised from the ranked list till the expiry of the period of three years, the duration of the ranked list shall be extended for a further period of one year or till at least one candidate is advised from the list whichever is

earlier.

- (ii) Candidates should submit application for this post to any one of the above districts and should note the name of that District against the relevant column in the application. Applications should not be submitted to more than one district in response to this notification. If applications are submitted contrary to the above direction, and if he/she is selected, his/her name will be removed from the Ranked List and disciplinary action will be taken against him/her.
- (iii) In the case of change in Caste/Community noted in the SSLC book, candidates must claim their original caste in the application and shall produce Caste Certificate/Non-Creamy Layer Certificate issued by the Revenue authorities and the gazette notification publishing the change of caste at the time of OTR verification for selection to the above post.
- (iv) The selection in pursuance of this notification will be made on a revenue district basis, subject to the special conditions laid down in G.O. (Ms)No.154/71/PD dated, 27.05.1971. A candidate advised for appointment in one revenue district from the Ranked List prepared is not eligible for transfer to another district unless he/she completes five years continuous service from the date of commencement of service in the former district. Even if transfer is allowed after five years, it will be subject to the rules in G.O(MS)No.4/61/PD, dated 02.1.1961. Candidates already in Government service holding this post in this Department in any one district are prohibited from applying again for this post, but they can apply to higher posts when notified.
- (v) As per GO(Rt.) no.394/2019/SJD dated 29/06/2019, vacancies will not be set apart for 3% reservation for differently abled candidates.

19-36 i,e Only candidates born between 02.1.1983 and 01.01.2000 (both dates included) are eligible to apply for this post with usual age relaxation to Scheduled Caste/ Scheduled Tribes and other backward Communities .

Certificate of Ayurveda Pharmacist Course recognised by the Government.

(2) Candidates claiming equivalent qualification should produce relevant Government orders during verification to prove that the qualification claimed is equivalent to the prescribed qualification for the post

8. Mode of submitting Applications :-

Candidates must register as per "ONE TIME REGISTRATION" with the Official Website of Kerala Public Service Commission 'www.keralapsc.gov.in' before applying for the post. Candidates who have registered can apply by logging on to their profile using their User-ID and password. Candidates must click on the `Apply Now' button of the respective posts in the Notification Link to apply for a post. The photograph uploaded should be one taken on or after 31/12/2010. Name of the candidate and the date of taking photograph should be printed legibly at the bottom portion. The photograph once uploaded meeting all requirements shall be valid for 10 years from the date of taking the photograph. There is no change in other instructions regarding the uploading of photographs. No application fee is required. Candidates shall take a printout of the application by clicking the link Registration Card in their profile. Candidates are responsible for the correctness of the personal information and secrecy of password. Before the final submission of the application on the profile, candidates must ensure the correctness of the information in their profile. They must quote their User-ID for further communication with the Commission. Application submitted is provisional and cannot be deleted or altered after submission. The Application will be summarily rejected if noncompliance with the notification is found in due course of processing. Documents to prove Qualification, experience, Community, age etc. have to be produced as and when called for. Candidates who have Aadhar Card should add Aadhar Card as I.D proof in their profile.
