Applications are invited online only from qualified candidates belonging to the following community of Kerala state against NCA vacancy for selection to the undermentioned post in Kerala Government Service.

The above vacancy is now in existence. The Ranked list published by the Commission in response to this notification will be valid until candidates are advised and appointed against the vacancies earmarked for **Muslim community** but remain unfilled due to the paucity of candidates during the currency of the Ranked List published on **07.02.2017** for the post (**Category No.428/12;Gazette date:31.07.2012**).**This is the second NCA Notification** published due to the non-availability of sufficient candidates belonging to the above mentioned community for the post as per **first NCA Notification (Category No.292/2017;Gazette date:18.08.2017)**.

Note: As per GO(P)No.01/2015/SJD dated.05.01.2015 differently abled candidates with Locomotor disability/Cerebral Palsy are identified as suitable for appointment to this post. Hence differently abled candidates with Blindness/Low Vision,Hearing Impairment are not eligible to apply for this post.

- 5. Method of appointment** : Direct Recruitment (From candidates belonging to Muslim community only)

Note: Applications submitted by candidates belonging to communities other than Muslim community will summarily be rejected. Individual communication regarding rejection memo of their application will not be issued.

- 6. Age limit** : 23-39;Only candidates born between 02.01.1980 and 01.01.1996 (both dates included) are only eligible to apply for the post.(Including the relaxation as per para 2(1) of the General Conditions) (For other conditions regarding age relaxation please see para 2 of the General Conditions except 2(1))

- 7. Qualifications:**

1) a) M.Sc (Clinical Psychology) or any other equivalent qualification from a

UGC recognized University / Institute owned by Government of Kerala / National Institutes of Government of India.

OR

b) M.A / M.Sc in Psychology or any other equivalent qualification from a UGC recognized University / Institute owned by Government of Kerala / National Institutes of Government of India.

2) M.Phil in Clinical Psychology or equivalent 2 year course from a RCI approved University / College / Institution owned by Government of Kerala / National Institutes of Government of India / UGC recognized University.

3) Rehabilitation Council of India Registration as “Clinical Psychologist”.

- Note:**
- 1) Candidates who claim equivalent qualification instead of qualification mentioned in the Notification shall produce the relevant Government Order to prove the equivalency at the time of verification, then only such qualifications shall be treated as equivalent to the prescribed qualification .
 - 2) In the case of difference in original Caste/Community claimed in the application and that entered in SSLC book, the candidate shall produce a Gazette Notification in this regard, along with Non Creamy Layer Certificate/Community Certificate at the time of Certificate Verification.
 - 3) KS&SSR Part II Rule 10 (a) (ii) is applicable .

8 Mode of submitting Application :

- (a) Candidates must register as per ONE TIME REGISTRATION with the official Website of Kerala Public Service Commission www.keralapsc.gov.in before applying for the post. Candidates who have registered can apply by logging on to their profile using their User ID and password. Candidates must click on the Apply Now button of the respective posts in the Notification Link to apply for a post. The Photograph uploaded should be taken after 31.12.2010. Name of the candidate and the date of photograph taken should be printed legibly at the bottom portion. The Photograph once uploaded meeting all requirements shall be valid for 10 years from the date of uploading. There is no change in other instructions regarding the uploading of photographs. No application fee is required. Candidates shall take a printout of the application by clicking the link Registration Card in their profile. Candidates are responsible for the correctness of the personal information and secrecy of password. Before the final submission of the application on the profile candidates must ensure correctness of the information in their profile. They must quote the User ID for further communication with the Commission. Application submitted is provisional and cannot be deleted or altered after submission. The application will be summarily rejected if

noncompliance with the notification is found in due course of processing . Documents to prove qualification , age, community etc. have to be produced as and when called for.

- (b) If a Written/OMR/Online Test is conducted as part of this selection ,candidates shall submit a confirmation for writing the examination through their One time Registration Profile. Such candidates alone can generate and download the Admission Tickets in the last 15 days till the date of Test. The applications of candidates who do not submit confirmation within the stipulated period will be rejected absolutely .Appropriate disciplinary action as per Rules of Procedure Rule 22 shall be initiated against those candidates who submit applications with bogus claims of qualification regarding education, experience etc. and submit confirmation for writing the examination , irrespective of whether they are present or absent for the examination. The periods regarding the submission of confirmation and the availability of Admission Tickets will be published in the Examination Calendar itself. Information in this regard will be given to the candidates in their respective profiles and in the mobile phone number registered in it.
- (c) Candidates who have AADHAAR card should add AADHAAR Card as I.D Proof in their profile.
