**NOTE (2) :-** Candidates who wish to obtain a photocopy of their OMR answer sheet (Part A& Part B) relating to this section shall remit the fee of Rs.335/-in any of the Treasuries in the state (Head of Account:0051 PSC-800-STATE PSC-99 other receipts). The duly filled in application in the prescribed form in the Commission's website www.keralapsc.gov.in along with original chalan should be submitted to The Secretary, Kerala Public Service Commission, Pattam, Thiruvananthapuram within 45 days from the date on which this Ranked List is uploaded in the Commissions website. A copy of an answer sheet will be issued only once to a candidate. Candidates are prohibited from applying for a copy of an answer sheet which is not their own ,and legal proceedings will be initiated against those who do so. The last date of receipt of application is **13.04.2020**. Application received after the prescribed date will not be entertained.

**NOTE (3):-** A period of 45 days time to apply for rechecking of Answer scripts will be allowed to candidates with effect from the date on which this Ranked List is uploaded in the Commissions website. The candidates can avail only one chance. "Applications for rechecking of answer scripts should be submitted in the prescribrd form available free of cost from the Enquiry sections of various offices of the Commission or its photocopy,or downloaded and printed in A4 size paper from the Commission's website www.keralapsc.gov.in or photocopied there from.Applications submitted in any other manner will not be considered."

The Application for rechecking, along with original chalan receipt for the prescribed fee Rs.85/- under the head of account "0051-PSC 105 State PSC 99-Examination Fee",addressed to The Secretary,Kerala Public Service Commission,Pattam, Thiruvananthapuram should reach the office on or before **13.04.2020** Application for rechecking received after the stipulated time will not be entertained and fee once remitted will not be refunded.

**NOTE (4):-** Any candidate can relinquish his/her right for appointment in writing duly attested by a Gazetted Officer of State/ Central Government with Signature, Name, Designation and Office Seal along with a notarized affidavit and a self attested copy of an identity proof bearing a photograph as enlisted in the general conditions. The request for relinquishment received within 15 days from the date of publication of Ranked List in official website of the Commission will be honoured against the requisitions of vacancies that are pending with the Commission up to the finalization of the Ranked List. After the publication of the Ranked List, the request for relinquishment will be considered only if such request is received on or before the date of receipt of requisition, based on which he/she is to be advised.

**NOTE (5)** :- The A Part and B Part of OMR Scripts will be destroyed after completing six months period from the date of finalization of Ranked List, ie on **21.05.2020**.
