The dulv prescribed filled in application in the form (available from the Commission's website chalan should be submitted to The District Officer, www.keralapsc.gov.in) along with the original Kerala Public Service Commission District Office, Andamukkam, Kollam within 45 days from the date on which this ranked list is uploaded in the Commission's website. A copy of an answer sheet will be issued only once to a candidate. Candidates are prohibited from applying for a copy of an answer sheet which is not their own, and legal proceedings will be initiated against those who do so. The last date of receipt of application is 18.07.2020. Applications received after the prescribed date will not be entertained.

NOTE III:

A period of 45 days time to apply for rechecking of Answer Scripts will be allowed to candidates **with** effect from the date on which this Ranked List is uploaded in the Commission's website. The candidates can avail only one chance."Applications for rechecking of answer scripts should be submitted in the prescribed form available free of cost from the Enquiry Sections of the various offices of the Commission or its photocopy, or downloaded and printed in A4 size paper from the Commission's Website www.keralapsc.gov.in or photocopied there from. Applications submitted in any other manner will not be considered."
