Candidates are prohibited from applying for a copy of an answer sheet which is not their own, and legal proceedings will be initiated against those who do so.

NOTE (III):- A period of 45 days time to apply for rechecking of Answer Scripts will be allowed to candidates with effect from the date on which this Ranked List is uploaded in the Commission's website. The candidates can avail only one chance." Applications for rechecking of answer scripts should be submitted in the prescribed form available free of cost from the Enquiry sections of the various offices of the Commission or its photocopy, or downloaded and printed in A4 size paper from the Commission's Website www.keralapsc.gov.in or photocopied there from.Applications submitted in any other manner will not be considered. The application for rechecking, along with original chalan receipt for the prescribed fee of Rs.85/- under the head of account "0051 - PSC 105 State PSC 99 - Examination Fee", addressed to The Deputy Secretary (Examinations), Kerala Public Service Commission Pattom, Thiruvananthapuram-4 should reach the office within 45 days from the date of uploaded of this Ranked List (ie, on or before 13.01.2021). Application for rechecking received after the stipulated time will not be entertained and fee once remitted will not be refunded.

**NOTE (IV):-** "Any candidate can relinquish his/her right for appointment in writing duly attested by a Gazetted Officer of State/Central Government with signature, name, designation and office seal along with a notarized affidavit and a self attested copy of an ID Proof bearing photograph as enlisted in the General conditions.
