Applications are invited online only through One Time Registration from qualified candidates belonging to Ezhava/Thiyya/Billava Communities of Kerala State for selection to the following post.

- 1 Department : Kerala Ceramics Limited
- 2 Name of Post : Electrician Gr. II
- 3 Scale of Pay : ₹ 3560-4935 (PR)
- 4 Number of vacancies : NCA- E/T/B -01 (One)

Note:- (i) The above vacancy is existing at present. The Ranked List published as per this notification will be valid until candidates are advised and appointed against the vacancies earmarked to the Ezhava/Thiyya/Billava Communities but remain unfilled due to the paucity of candidates during the currency of the Ranked List published on 18.01.2017 for the post (Cat.No.661/2014).

- (ii) The Kerala Public Service Commission shall have the power to cancel the advice for appointment of any candidate to the above post, if it is subsequently found that such advise was made under some mistake. On such cancellation the appointing authority shall terminate the service of candidate, provided that, the cancellation of advice for appointment by the Commission and subsequent termination of service of the candidate by the appointing authority shall be made within the period of probation or 240 days from the date of joining duty whichever is earlier.

- 5 Method of Appointment : Direct Recruitment (Candidates belonging to Ezhava/ Thiyya/Billava Communities only)

Note :- The applications submitted by candidates belonging to the communities other than Ezhava/Thiyya/Billava Communities will be summarily rejected. No rejection memo will be issued to them individually.

- 6 Age : 18-42 Only candidates born between 02.01.1978 and 01.01.2002 (both dates included) are eligible to apply for this post. (including Para 2(i) of the General Conditions)

Note:- Applications of candidates belonging to communities other than the above mentioned will be summarily rejected. Individual rejection memo will not be sent to them.

- Note:
- (1) Rule 10(a)ii of Part II of KS&SSR is applicable.
 - (2) Candidates who claim equivalent qualification instead of qualification mentioned in the notification shall produce the relevant Government Order to prove the equivalency at the time of verification, then only such qualification shall be treated as equivalent to the prescribed qualification concerned.
 - (3) If the caste of a candidate is wrongly mentioned in the SSLC book, the candidate should claim their original caste in the application and should produce the community certificate /Non-creamy layer certificate issued from the revenue authority concerned along with the Gazette Notification of the same at the time of certificate verification.
 - (4) Appropriate disciplinary actions, based on KPSC Rules of Procedure Rule 22, will be pursued against those candidates who give confirmation for writing examination by making false claims about qualification such as education, experience etc regardless of attending or not attending the examination.

8. Mode of submitting applications:

(a) Candidates must register as per ONE TIME REGISTRATION with the official Website of Kerala Public Service Commission www.keralapsc.gov.in before applying for the post. Candidates who have registered can apply by logging on to their profile using their User-ID and Password. Candidates must click on the '**Apply Now**' button of the respective posts in the Notification Link to apply for a post. The Photograph uploaded should be taken after 31.12.2010. Name of the candidate and the date of photograph taken should be printed legibly at the bottom portion. The photograph

once uploaded meeting all requirements shall be valid for 10 years from the date of uploading. There is no change in other instructions regarding the uploading of photographs. No application fee is required. Candidates are responsible for the correctness of the personal information and secrecy of password. Before the final submission of the application on the profile candidates must ensure correctness of the information in their profile. They must quote the User-ID for further communication with the Commission. Application submitted is provisional and cannot be deleted or altered after submission. **Candidates are advised to keep a printout or soft copy of the online application for future reference. Candidates can take the printout of the application by clicking on the link 'My applications' in their profile. All correspondences with the Commission, regarding the application should be accompanied with the print out of the application.** The application will be summarily rejected if non-compliance with the notification is found in due course of processing. Original documents to prove qualification, experience, age, Community etc. have to be produced as and when called for.

(b) "If written/OMR/Online Test is conducted as part of this selection candidates possessing requisite qualification as per Para 7 above alone shall submit a **confirmation** for writing the examination through their One Time Registration profiles. Such candidates alone can generate and download the Admission Tickets in the last 15 days till the date of Test. The application of candidates who do not submit confirmation within the stipulated period, will be rejected absolutely. The periods regarding the submission of confirmation and the availability of admission tickets will be published in the examination calendar itself. Information in this regard will given to the candidates in their respective profiles and in the mobile phone number registered in it."

(c) "Candidates who have Aadhaar Card should add Aadhaar Card as ID proof in their profile".
