- (3) In the absence of persons with B.Ed. Degree as specified in item (1) and (2) above, persons with B.Ed. Degree in any subject acquired after a regular course of study from any of the Universities in Kerala or a qualification recognised as equivalent thereto by any of the Universities in Kerala.

- (3) In the absence of persons with B.Ed. Degree as specified in item (1) and (2) above, persons with B.Ed. Degree in any subject acquired after a regular course of study from any of the Universities in Kerala or a qualification recognised as equivalent thereto by any of the Universities in Kerala.
- III Must have passed the State Eligibility Test (SET) for the post of Higher

Secondary School Teachers conducted by the Government of Kerala or by the Agency authorized by the State Government.

- <u>Note</u> (1)- In the absence of B.Ed. Degree holders, candidates having Master® Degree with not less than 45% of marks and who have passed the State Eligibility Test will be considered. Preference will be given to those who have acquired Ph.D/M.Phil Degree or qualified at Junior Research Fellowship/National Eligibility Test(NET) The teachers appointed under this provision will have to acquire B.Ed. at their own expense within five years from the date of entry in service.
 - (2) Persons who have acquired M.Ed in the subject concerned recognized by any university in Kerala are exempted from B.Ed qualification.

Exemptions for All Posts (Sl. Nos. 1 to 9)

- 1) Those persons who have passed the State Level Eligibility Test for the post of College Lecturers conducted by Government of Kerala are exempted from passing the State Eligibility Test for Higher Secondary School Teacher.
- 2) Those persons who have passed the National Eligibility Test/Junior Research Fellowship shall be exempted from passing the State Eligibility Test.
- 3) Persons with Ph.D./M.Phil/M.Ed. Degree shall be exempted from passing the State Eligibility Test provided the M.Phil. in the concerned subject should be one awarded by any of the Universities in Kerala or recognised as equivalent thereto by any of the Universities in Kerala.
- 4) The teachers who have completed 10 (Ten) years of approved teaching service at the High School level in the General Education Subordinate Service shall be exempted from passing the State Eligibility test for Higher Secondary School Teacher.

Note: Higher Secondary School Teacher means Full-Time post of Higher Secondary School Teacher.

Note: **1.** Rule 10(a)(ii) of part II of KS&SSR is applicable to all the posts Sl No.01 to 09

- **2.** Candidates who claim equivalent qualification instead of qualification mentioned in the notification shall produce the relevant Government Order to prove the equivalency at the time of verification, then only such qualification shall be treated as equivalent to the prescribed qualification concerned.
- **3.** If the caste of candidates is wrongly mentioned in their SSLC book, they should claim their original caste in their applications and should produce Community Certificate issued from concerned revenue authority and the Gazette Notification for the same at the time of certificate verification.

4. Appointed candidate will be on probation for a total period of two years on duty within a continuous period of three years.

7 Mode of Submitting application:

Candidates must register as per 'ONE TIME REGISTRATION' with the official website of Kerala Public Service Commission www.keralapsc.gov.in before applying for the post. Candidates who have already registered can apply by logging on to their profile using their User-ID and password. Candidates must click on the 'Apply Now' button of the respective posts in the Notification Link to apply for a post. No application fee is required. Candidates can view and have a printout of the details in the profile by clicking the link Registration Card. Candidates are responsible for the correctness of the personal information and secrecy of password. Before the final submission of each application, the candidates must ensure correctness of the information on their profile. They must quote the User-ID for further communication with the Commission. Application once submitted is treated as provisional and cannot be deleted or The application will be summarily rejected if altered after submission. noncompliance with the notification is found in due course of processing. Documents to prove qualification, experience, community, age etc. have to be produced as and when called for. The profile correction made by the candidate or in the office of the Kerala Public Service Commission on request after the last date fixed for receipt of application will not be reflected in the application. Such corrections will be in effect on the date on which corrections have been made.
