- (i) Conventional type applications will be summarily rejected. Candidates shall apply online only by One Time Registration to www.keralapsc.gov.in.
- (ii) In the absence of suitable candidates, the vacancies set apart for By Transfer recruitment shall be filled up by the candidates from the Ranked List prepared for Direct recruitment.
- (iii) The applicant should be an approved probationer/Full member of the Kerala General Education subordinate service as on the date of application.
- (iv) Separate Ranked Lists will be prepared for each district in pursuance of this notification. The Ranked lists thus prepared and published by the Commission, shall remain in force for a minimum period of one year, subject to the condition that the said list will continue to be in force till the publication of a new list after the expiry of the minimum period of one year or till the expiry of three years whichever is earlier. Candidates will be advised for appointment against the vacancies, if any, reported during the currency of the lists. In case no candidate is advised from the ranked list till the expiry of the period of three years, the duration of the ranked list shall be extended for a further period of one year or till at least one candidate is advised from the list whichever is earlier.
- (v) The selection in pursuance of this notification will be made on a revenue district basis, subject to the special conditions laid down in G.O. (Ms)No.154/71/PD dated, 27.05.1971. A candidate advised for appointment in one revenue district from the Ranked List prepared is not eligible for transfer to another district unless he/she completes five years continuous service from the date of commencement of service in the former district. - (ii) The Employees of the General Education Department who entered service before 31.03.2012 and have completed the prescribed period of service as Clerk/Typist/Attender/Office Attendant are exempted from acquiring K-TET qualification .
- (iii) The applicant should have taken Botany or Zoology or Home Science or Micro Biology as main subject for Graduation/Post graduation.
- (iv) Diploma in Rural Service awarded by the National Council for Rural Higher Education will also be treated as equivalent to Degree for the above purpose.
- (v) The candidates who have acquired B.Sc Ed in Chemistry Botany Zoology stream conducted by the Regional Institute of Education Mysore of NCERT are also eligible to apply for the post (GO (P) No 117/13/G Edn dtd 30/3/13).

Candidates must register as per "ONE TIME REGISTRATION" with the Official Website of Kerala Public Service Commission 'www.keralapsc.gov.in' before applying for the post. Candidates who have registered shall apply by logging in to their profile using their user ID and password. Name of the candidate and the date of taking photograph should be printed at the bottom portion. The photograph once uploaded meeting all requirements shall be valid for 10 years from the date of taking photograph. There is no change in other instructions regarding the uploading of photographs.
