Note :- (7) Candidates belonging to SC/ST communities shall upload in profile and produce in person the Community Certificate obtained from the Revenue Authority not below the rank of Tahsildar along with other documents at the time of OTR verification.

Note :- (8) Copy of answer scripts of the OMR Test held on **08-09-2020** will be issued to those candidates who, apply for the same remitting the prescribed fee after approval of the Ranked List.
