**FIRST NCA NOTIFICATION**

Applications are invited online only by One Time Registration Scheme from qualified candidates belonging to the reservation group of Scheduled Caste community of Kerala State for appointment in the undermentioned post in Kerala Government Service. Before applying for the post the candidate shall register as per One Time Registration Scheme through the official website of Kerala Public Service Commission.

- 1 Department : Technical Education (Govt. Polytechnics)
- 2 Name of Post : Lecturer in Civil Engineering
- 3 Scale of pay : ₹ 15600-39100/- (AICTE pay band with AGP 5400)
- 4 Number of vacancy : Scheduled Caste -01(one)

The above vacancy is now in existence. The Ranked list published as per this notification will be valid until a candidate is advised and appointed against the vacancy earmarked for the above mentioned community but remains unfilled and also against vacancies that may arise due to the paucity of candidates during the currency of the Ranked list published on 17/08/2018 for the post ( Category number 211/2015).

- 5 Method of appointment : Direct Recruitment from candidates belonging to the Scheduled Caste community only

Note : Applications submitted by candidates belonging to the communities other than the above will be summarily rejected. Individual communications regarding the rejection of their applications will not be issued.

- 6 Age limit : 20-44, Only candidates born between 02.01.1977 and 01.01.2001(both dates are included) are eligible to apply for this post )
  - 1.) Officers (belonging to the SC community only) of the Technical Education, Public works, Public Health Engineering , Industries, Architecture and Town Planning Departments may also apply. They will be allowed age relaxation to the extent of their service in those departments ( Maximum age

limit shall not exceed 50 years as on 01.01.2021)

- 7 Qualifications : First Class Bachelor's Degree in Civil Engineering from a recognised University after undergoing a regular course of Study.

Note:- i)Rule 10 a (ii) of Part II KS&SSR is applicable.

ii)Candidates who claim equivalent qualification instead of qualification mentioned in the Notification shall produce the relevant Government order to prove the equivalency at the time of verification, then only such qualification shall be treated as equivalent to the prescribed qualification concerned.

iii)In the case of difference in original caste/ community claimed in the application and that entered in SSLC book, the candidates shall produce a Gazette notification in this regard, along with Non Creamy Layer Certificate/ Community Certificate at the time of certificate verification.

### **Liability to serve in Defence Services:**

Persons appointed to the post shall be liable, notwithstanding that at the time of requisition they are holding higher appointments, to serve for a minimum period of four years (including period spent in training) in the Defence Services or on assignments relating to Defence efforts anywhere in India or abroad, if so required. The liability to serve in the Defence Services will be limited to the first 10 years of service and will not ordinarily apply to persons above 40 years of age.

### 8. Mode of submitting Application:-

a. Candidates must register as per ONE TIME REGISTRATION with the official Website of Kerala Public Service Commission [www.keralapsc.gov.in](http://www.keralapsc.gov.in) before applying for the post. Candidates who have registered can apply by login on to their profile using their User-ID and password. Candidates must click on the Apply Now button of the respective posts in the Notification Link to apply for a post. The photograph uploaded should be taken after 31.12.2011. Name of the candidate and the date of photograph taken should be printed legibly at the bottom portion. The photograph ones uploaded meeting all requirements shall be valid for ten years from the date uploading. There is no change in other instructions regarding the uploading of photographs. No application fee is required. Candidates are responsible for the correctness of the personal information and secrecy of password. Before the final submission of the application on the profile candidates must ensure correctness of the information in their profile. They must quote the User-ID for further communication with the commission. Application submitted is provisional and cannot be deleted or altered after submission. **Candidates are advised to keep a printout or soft copy of the online application for future reference.**

**Candidates can take the print out of the application by clicking on the link 'My application' in their profile. All correspondences with commission, regarding the application should be accompanied with the print out of the application.** The application will be summarily rejected if non-compliance with the notification is found in view course of processing. Original Documents to prove qualification, experience ,age,community, etc. have to be produced as and when called for.

b. Appropriate disciplinary action as per Rules of Procedure Rule 22 shall be initiated against those candidates who submit applications with bogus claims of qualification regarding education,experience etc and submit confirmation for writing the examination ,irrespective of whether they are present or absent for the examination.

c. If written/OMR/Online Test is conducted as part of this selection, candidates shall submit a confirmation for writing the examination through their One Time Registration Profile. Such candidates alone can generate and download the Admission tickets in the last 15 days till the date of test. The applications of candidates who do not submit confirmation within the stipulated period will be rejected absolutely. The periods regarding the submission of confirmation and availability of Admission Tickets will be published in the Examination Calendar itself. Information in this regard will be given to the candidates in their respective profiles and in the mobile phones registered in it.

d. Candidates who have AADHAAR card should add AADHAAR as ID Proof in their profile.
