Applications are invited online only from qualified candidates for appointment in the under mentioned post. Before applying for the post candidates should register as per the One Time Registration through the official website of Kerala Public Service Commission. Candidates who have already registered can apply through their profile. **Candidates who have AADHAR CARD should add AADHAR Card as I.D. Proof in their Profile.**

Note 1. The above vacancies are now in existence. The list of selected candidates published by the Commission in response to this notification shall remain in force for a minimum period of one year provided that the said list will continue to be in force till the publication of a new list after the expiry of the minimum period of one year or till the expiry of three years whichever is earlier. Candidates will be advised from the said list against the vacancies noted above and also against the vacancies if any reported to the Commission in writing during the period of currency of the list.

2. Kerala Public Service Commission shall have the power to cancel the advice for appointment of any candidates to the above post, if it is subsequently found that such advise was made under some mistake. On such cancellation the Appointing Authority shall terminate the service of candidate, provided that, the cancellation of advice for appointment by the Commission and subsequent termination of service of the candidate by the Appointing Authority shall be made within the period of his/ her probation or 240 days from the date of his /her joining duty whichever is earlier.

3. 3% of the vacancies for the post shall be reserved for differently abled candidates with Locomotor Disability/Cerebral Palsy, Hearing Impairment as per G.O.(P) No.01/2013/SJD dtd 03.01.2013.

- 6. Age Limit : 18-36. Only candidates born between 01.01.2003 and 02.01.1985 (both dates included) are eligible to apply for this post. SC/ST and OBC candidates are eligible for usual age relaxation.

Note:- The regular employees working in the above concern will be given age relaxation to the extent of their service in the Board from upper age limit, if they possess prescribed qualifications. But the maximum age limit shall in no case exceed 50 (Fifty) years.

- 7. Qualifications :**
1. **Must have passed SSLC or its equivalent**
 2. **Must possess any of the following qualifications:-**
 - i) **Pass in Section A&B of the Membership Examination of the Institute of Engineers (India) in Engineering (Civil)**
 - ii) **Diploma in Engineering (Civil) (3 year course) issued by Government of Kerala or Diploma recognised by Government as equivalent thereto.**

- 1 Rule 10 (a) ii of Part II KS & SSR applicable.
 - 2 Candidates who claim equivalent qualification instead of qualification mentioned in the notification shall produce the relevant Government Order to prove the equivalency at the time of verification, then only such qualification shall be treated as equivalent to the prescribed qualification concerned.
 - 3 In the case of difference in original Caste/Community claimed in the application and that entered in SSLC Book , the candidate shall produce a Gazette Notification in this regard, along with Non Creamy Layer/Community Certificate at the time of certificate verification.
 - 4 Appropriate disciplinary/penal action as per Rule 22 of KPSC Rules of Procedure, will be initiated against those candidates who give confirmation for writing the examination by providing false claims about their qualifications/ experience irrespective of whether they have attended or abstained from the examination.

8 Probation

The candidates selected to the post shall from the date of appointment be on probation for a period of two years within a continuous period of three years.

9 Method of submitting applications

Candidates must register as per ONE TIME REGISTRATION with the official Website of Kerala Public Service Commission www.keralapsc.gov.in before applying for the post. Candidates who have registered can apply by logging on to their profile using their User-ID and Password. Candidates must click on the 'Apply Now' button of the respective posts in the Notification Link to apply for a post. The Photograph uploaded through One Time

Registration should be taken after 31.12.2011. Name of the candidate and the date of photograph taken should be printed legibly at the bottom portion of the photograph. The photograph once uploaded meeting all requirements shall be valid for 10 years from the date of uploading. There is no change in other instructions regarding the uploading of photographs. No application fee is required. Candidates are responsible for the correctness of the personal information and secrecy of password. Before the final submission of the application on the profile candidates must ensure correctness of the information in their profile. They must quote the User-ID for further communication with the Commission. Application submitted is provisional and cannot be deleted or altered after submission. **Candidates are advised to keep a printout or soft copy of the online application for future reference. Candidates can take the printout of the application by clicking on the link 'My applications' in their profile. All correspondences with the Commission, regarding the application should be accompanied with the print out of the application.** The application will be summarily rejected if non-compliance with the notification is found in due course of processing. Original documents to prove qualification, experience, age, community etc. have to be produced as and when called for.

The periods regarding the submission of confirmation and the availability of admission tickets will be published in the examination calender itself.
