**NOTIFICATION**

The following is the list of candidates found suitable by the Commission for selection to the post of **WOMEN CIVIL EXCISE OFFICER ( NCA -HN) (ERNAKULAM)** on ₹ 20,000-45,800/- in **EXCISE DEPARTMENT**, found suitable by the Commission and arranged in the order of merit based on OMR examination held on **27/07/2019**, Endurance Test held on **23/01/2020** and Physical Measurement and Physical Efficiency Test held on **20/01/2021**. This Ranked List is brought into force with effect from **30/04/2021** and will be valid until candidates are advised and appointed against the NCA vacancies that arise due to the paucity of candidates belonging to SC community during the currency of mother Ranked List published on **04/05/2015 (Cat No 261/2014)** or one year from the date on which this NCA Ranked List is brought into force, whichever is earlier. The candidates remaining in the list at the time of cancellation will have no claim at all for appointment on the basis of the inclusion of their names in the list.

Since a common objective type (OMR Valuation) test was held for this post, the marks awarded to the candidates included in the Ranked List and marks of OMR Test relating to all candidates appeared for the test will be published only after the publication of the Ranked List (including NCA Notifications) which will be finalised on the basis of the Common Test.

According to the existing procedure, revaluation of Answer Script is not allowed. But Answer Scripts will be rechecked if the candidates apply for in the prescribed application form available free of cost from the Enquiry Sections of the various Offices of the Commission or its photocopy, or downloaded and printed in A 4 size paper from the Commission's website [www.keralapsc.gov.in](http://www.keralapsc.gov.in) or Photocopied there from along with prescribed fee of **Rs. 85/- (Rupees Eighty Five Only)** under the Head of Account "**0051 - PSC - 105 State PSC 99 - Examination Fee**" addressed to the District Officer, Kerala Public Service Commission District Office, Ernakulam-682016. Applications submitted in any other manner will not be considered. A period of 45 (Forty Five) days time to apply for rechecking of Answer Scripts will be allowed to candidates with effect from the Date of uploading of the Ranked List in website. The last date for receipt of applications is **11/07/2021**. The candidates can avail only one chance after the Approval of Ranked List. Rechecking of invalidated answer scripts due to any defects will not be considered. Application for Rechecking received after the stipulated time will not be entertained and Fee once remitted will not be refunded.

Candidates who wish to obtain a photocopy of their OMR Answer Sheets (Part A & Part B) relating to this selection shall remit a Fee of **Rs. 335/- (Rupees Three Hundred and Thirty Five only)** in any of the Treasuries in the State (Head of Account : **0051 - PSC - 800 - State PSC -99-Other Receipts**). The duly filled in application in the prescribed form available from the Commission's website [www.keralapsc.gov.in](http://www.keralapsc.gov.in) along with the original chalan should be submitted to the District Officer, Kerala Public Service Commission District Office, Ernakulam-682016 within **45 (Forty Five)** days from the date

of uploading of the Ranked List in website. A copy of the answer sheet will be issued only once to a candidate. Copies of OMR answer sheets invalidated due to any defect will not be issued. Candidates are prohibited from applying for copy of an answer sheet which is not their own, and legal proceedings will be initiated against those who do so. The last date for receipt of applications is **11/07/2021**. Applications received after the prescribed date will not be entertained.

The result of rechecking of OMR scripts will be intimated in due course. But photo copy of the OMR and answer scripts will be issued only after the publication of all the Ranked Lists to be finalised on the basis of the common test for each posts.

The entries put in column 5 are based on the communities specified by the candidates in their application forms and proved by them with necessary documents. The candidates whose communities have not been correctly noted in the list as proved by them should intimate the fact to the District Officer, Kerala Public Service Commission District Office, Ernakulam -682016 within one month from the date of publication of the list to get the benefit of reservation to which they are entitled to. In the absence of timely information regarding discrepancies, if any, the candidates will be advised as incorporated in the list.

***“Any candidate can relinquish his/her right for appointment in writing duly attested by a Gazetted Officer of State/Central Government with signature, Name, Designation and Office Seal along with a notarized affidavit and a self attested copy of an ID proof bearing photograph as enlisted in the General Conditions” The request for relinquishment received within 15 days from the date of publication of Ranked List in the official website of the Commission will be honoured against the requisitions of vacancies that are pending with the Commission upto the finalization of ranked list. After the publication of the Ranked List, the request for relinquishment will be considered only if such request is received on or before the date of receipt of requisition, based on which he/she is to be advised.”***

The A part and B part of OMR scripts will be destroyed after completing 6 months period from the date of finalisation of Ranked list included in the common test held on 31/01/2019
