## **NOTIFICATION**

The following is the list of candidates found suitable by the Commission for selection to the post of Forest Driver (Direct Recruitment) (Category No. 120/2017) on ₹ 19,000-43,600/- in Forest Department in Pathanamthitta District on the basis of the result of the Objective Type Test (OMR Valuation) held on 04/04/2018, Physical measurement and Physical Efficiency Test held on 05/11/2020, 06/11/2020, 25/11/2020, 27/11/2020 & 31/12/2020 and Practical Test (T Test & Road Test) conducted on 17/02/2021 & 10/03/2021 and arranged in the order of merit.

The Ranked List is brought into force with effect from **08/06/2021**. The Ranked list shall remain in force for a minimum period of one year, subject to the condition that the said list will continue to be in force till the publication of a new list after the expiry of the minimum period of one year or till the expiry of 3 years whichever is earlier. Candidates from this list will be advised for appointment in accordance with the rules and orders regarding reservation and rotation as amended from time to time, if applicable, against vacancies reported to the Commission during the pendency of the list. As the advice for appointment depends on the occurrence of vacancies, there is no guarantee that all candidates included in this list will secure appointment. The candidates remaining in the list at the time of cancellation will have no claim for appointment on the basis of the inclusion of their names in the list.

The entries put in column 5 are based on the communities specified by the candidates in their application forms and proved by them with necessary documents. The candidates whose communities have not been correctly noted in the list as proved by them should intimate the fact to the District Officer, Kerala Public Service Commission, District Office, Pathanamthitta within one month from the date of publication of the list to get the benefit of reservation which they are entitled to. In the absence of timely information regarding discrepancies, if any, the candidates will be advised as incorporated in the list.

According to the existing procedure, re-valuation of Answer Script is not allowed. But answer script will be re-checked to see that all the answers are valued and there is no mistake in the totalling of marks, if prescribed fee of **Rs. 85/- (Rupees Eighty Five only)** is remitted in any one of the treasuries in the State under the head of account **"0051 PSC-105 State PSC-99 Examination Fee". The fee once remitted will not be refunded on any account.** The result of the rechecking will be intimated to the candidates from the Head office of the Commission. Application for rechecking of answer scripts should be submitted in the prescribed form available free of cost from the Enquiry Section of the various offices of the Commission or its photocopy or downloaded and printed in A4 size paper from the Commission's website **www.keralapsc.gov.in** or photocopied therefrom. Applications submitted in any other manner will not be considered. Valid applications for rechecking of answer script along with the original chalan receipt for the prescribed fee addressed to the **District Officer, Kerala Public Service Commission, District Office, Pathanamthitta shall reach this office within 45 days from the date on which the** 

## Ranked List is uploaded in the Commission's Website, ie on or before 01/08/2021. Application for rechecking received after the stipulated time will not be entertained.

Application for rechecking received from the candidates, whose Answer scripts have been invalidated, will not be considered.

Candidates who wish to obtain a photocopy of their OMR answer sheet (Part A & Part B) relating to this selection shall remit a fee of **Rs.335/- (Rupees Three Hundred and Thirty Five only)** by way of chalan in any of the treasuries in the State (Head of Account **0051 PSC-800 State PSC-99 other receipts).** The duly filled up application in the prescribed form (available from the Commission's website) along with the original chalan should be submitted to the **District Officer, K.P.S.C District Office, Pathanamthitta within 45 days from the date on which the Ranked List is uploaded in the Commission's Website.** A copy of the answer sheet will be issued only once to a candidate. Copies of OMR sheets invalidated due to any defect will not be issued. Candidates are prohibited from applying for copy of answer sheet which is not their own, and legal proceedings will be initiated against those who do so. The last date for receipt of application is **01/08/2021**. Application received after the prescribed date will not be entertained.

Since a Common Objective Type (OMR valuation) Test was held for this post, the marks awarded to the candidates included in the Ranked List and marks of OMR Test relating to all candidates appeared for the test will be published only after the publication of all the Ranked Lists (including NCA Ranked Lists) which will be finalised on the basis of the Common test. The result of rechecking of OMR scripts will be intimated in due course. But, Photocopy of the OMR Answer sheets will be issued only after the publication of all the Ranked Lists to be finalised on the basis of the common test for each post.

The A part and B part of the OMR scripts will be destroyed after completing 6 months period from the date of finalisation of Ranked Lists ie, on 07.12.2021.

"Any candidate can relinquish his/her right for appointment in writing duly attested by a Gazetted Officer of State/ Central Government with Signature, Name, Designation and Office Seal along with a notarized affidavit and a self attested copy of an ID proof bearing photograph as enlisted in the General Conditions". The request for relinquishment received within 15 days from the date of publication of Ranked List in the official website of the Commission will be honoured against the requisitions of vacancies that are pending with the Commission upto the finalisation of Ranked List. After the publication of the Ranked List, the request for relinquishment will be considered only if such request is received on or before the date of receipt of requisition, based on which he/she is to be advised"
