Note :- (6) SC/ST Candidates included in the Short List are required to produce Community Certificate issued by the Revenue authority and candidates belonging to other backward classes should produce Non- Creamy Layer Certificate issued by the Village Officer as per GO(P)No.81/09 SC/ST/DD dated 26.09.2009 at the time of OTR Verification.

Note :- (7) Copy of answer scripts of the OMR Test held on **07-11-2020** will be issued to those candidates who, apply for the same remitting the prescribed fee after approval of the Ranked List.
