Note :- (6) Candidates belonging to Othe Backward Classes included in this List who are requested to produce Non Creamy Layer Certificate as per G.O.(P) No. 81/09/SC/ST/DD dated 26.09.2009 shall produce the same along with the other documents. SC/ST Candidates included in the Short List are requested to produce Community Certificate issued under Rule 4 of Kerala (Scheduled Caste/Scheduled Tribes) Regulation of issue of Community Certificate Rules 2002 by Revenue Authority not below the rank of Tahsildar.

Note :- (7) Copy of answer scripts of the OMR Test held on **29-09-2020** will be issued to those candidates who, apply for the same remitting the prescribed fee after approval of the Ranked List.
