Note :- (5) Candidates belonging to Other Backward Community should produce Non Creamy Layer certificate issued by Village Officer and those who belong to SC/ST should produce Community Certificate (Either in form III or digitally signed) issued by Revenue Authorities not below the Rank of Tahsildar at the time of one time verification.

Note :- (6) Copy of answer scripts of the OMR Test held on **08-07-2021** will be issued to those candidates who, apply for the same remitting the prescribed fee after approval of the Ranked List.
