Applications are invited online only through 'One Time Registration' facility from qualified candidates for appointment in the under mentioned post in Kerala Government Service.

1. **Department** : Sainik Welfare
2. **Name of Post** : Welfare Organiser (From Ex service men only)
3. **Scale of pay** : Rs. 26500-56700/-(PR)
4. **No. of vacancies:** **District wise**

Notes :

- (i) Separate Ranked list will be prepared for each district in pursuance of this notification. The vacancies in the Sainik Welfare Department in each district will be filled up from the Ranked List prepared for that district as per this notification . The Ranked lists thus prepared and published by the Commission, shall remain in force for a minimum period of one year, subject to the condition that the said list will continue to be in force till the publication of a new list after the expiry of the minimum period of one year or till the expiry of three years whichever is earlier. Candidates will be advised for appointment against aforesaid vacancies and also against the vacancies, if any, reported during the currency of the lists. In case no candidate is advised from the ranked list till the expiry of the period of three years, the duration of the Ranked list shall be extended for a further period of one year or till at least one candidate is advised from the list whichever is earlier.
- (ii) The selection in pursuance of the notification will be made on a revenue district basis subject to the special conditions laid down in GO (MS) No.154/71/PD dated 27/05/1971. A candidate advised for appointment from the Ranked List prepared in one revenue district is not eligible for transfer to another district unless he/she completes five years continuous service from the date of commencement of service in the former district. Even if

transfer is allowed after five years, it will be subject to the rules in G.O. (P) No. 36/91/P&ARD, dated 02.12.1991 for inter district transfers. Candidates already in Government service holding this post in any district are prohibited from applying in response to this notification.

- (iii) More than one application shall not be submitted in response to this notification. If applications are submitted contrary to the above direction, and if he/she is selected, his/her name will be removed from the Ranked List and disciplinary action will be taken against him/her.
- (iv) If there is any change in caste with respect to the entries in SSLC, then such changes is to be published in the gazette notification and the same along with the Community Certificate/Non Creamy Layer certificate issued by the Revenue authorities, is to be produced to prove their claim in application, at the time of One Time Verification.

- 5. **Method of appointment** : Direct Recruitment (From Ex servicemen only)
- 6. **Age Limit** : 18-36 Candidates born between 02.01.1985 and 01.01.2003 (both dates included) only are eligible to apply for this post.
With usual age relaxation to Scheduled Castes , Scheduled Tribes and Other Backward Communities .

For concessions allowed in upper age limit, subject to the condition that the maximum age limit shall in no case exceed 50 (fifty) years (including all concessions) Please see para (2) of the General Conditions under part (II) of this notification.

7. **Qualifications :-**

Pass in SSLC or its equivalent.

Candidates should be Ex–Junior Commissioned Officer in the Army or Ex-Servicemen of equivalent rank in Navy or Air Force.

Note:-

- (i) KS&SSR Part II Rule 10(a) (ii) is applicable .
- (ii) Those who claim equivalent qualification shall produce the respective Government Order to prove the claim at the time of One Time Verification or as and when required by the Commission.
- (iii) All the Qualifications must be acquired on or before the last date of receipt of application.
- (iv) Discharge Certificate to prove as ex-servicemen to be produced as and when called for by the Commission.

9. **Method of submitting applications:-**

Candidates must register as per ONE TIME REGISTRATION with the official Website of Kerala Public Service Commission www.keralapsc.gov.in before applying for the post. Candidates who have registered can apply by logging in to their profile using their User-ID and Password. Candidates must click on the '**Apply Now**' button of the respective posts in the Notification Link to apply for a post. The Photograph uploaded should be taken after 31.12.2011. Name of the candidate and the date of photograph taken should be printed legibly at the bottom portion. The photograph once uploaded meeting all requirements shall be valid for 10 years from the date of taking photograph. There is no change in other instructions regarding the uploading of photographs. No application fee is required. Candidates are responsible for the correctness of the personal information and secrecy of password. Before the final submission of the application on the profile candidates must ensure correctness of the information in their profile. They must quote the User-ID for further communication with the Commission. Application submitted is provisional and cannot be deleted or altered after submission. **Candidates are advised to keep a printout or soft copy of the online application for future reference. Candidates can take the printout of the application by clicking on the link 'My applications' in their profile. All correspondences with the Commission, regarding the application should be accompanied with the print out of the application.** The application will be summarily rejected if non-compliance with the notification is found in due course of processing. Original documents to prove qualification, experience, age, Community etc. have to be produced as and when called for.

Candidates who have AADHAAR card should add AADHAAR card as I.D. Proof in their profile.

10. Last date of receipt of applications : 02 February 2022 Wednesday upto 12 midnight.

11. If Written Test/OMR/Online Test is conducted as part of this selection, candidates shall submit a confirmation for writing the examination through their One Time Registration profile. Such candidates alone can generate and download the Admission Tickets in the last 15 days till the date of Test. The applications of candidates who do not submit confirmation within the stipulated period will be rejected absolutely. The periods regarding the submission of confirmation and the availability of Admission Tickets will be published in the Examination Calendar itself. Information in this regard will be given to the candidates in their respective profiles and in the mobile phones registered in it. Candidates who have downloaded the Admission Ticket will alone be permitted to attend the examination. Appropriate disciplinary action as per Kerala Public Service Commission Rules of Procedure Rule 22 shall be initiated

against those candidates who submit applications with bogus claims of qualification regarding education, experience etc and submit confirmation for writing the examination, irrespective of whether they are present or absent for the examination.
