NOTE (1) :- According to the existing procedure, re-valuation of Answer Script is not allowed. But rechecking of marks will be done on payment of Rs. 85/-. The fee should be remitted in any one of the treasuries in the State under the head of account "0051 PSC - 105 State PSC- 99 Examination Fee" and original challan should be enclosed with the application. Applications for rechecking of answer scripts should be submitted in the prescribed form available free of cost from the enquiry sections of the various offices of the Commission or its photocopy or downloaded and printed in A4 size paper from the Commission's website: www.keralapsc.gov.in or photocopied therefrom. Applications submitted in any other manner will not be considered. The original challan receipt together with the application for rechecking should reach the District Officer, K.P.S.C District Office, Wayanad, 673122 within 45 days from the date on which this Ranked List is uploaded in the commission's website . The fee once remitted will not be refunded on any account.

NOTE (2) Candidates who wish to obtain a photocopy of their OMR answer Script (Part A & Part B) relating to this selection shall remit a fee of Rs. 335/- by way of challan in any of the treasuries in the State under the Head of Account 0051 PSC-800 State PSC - 99 other receipts. The duly filled up application in the prescribed form (available from the commission's website) along with the original chalan should be submitted to the District Officer, K.P.S.C District Office, Wayanad within 45 days from the date on which the Ranked List is uploaded in the Commissions website. Application for rechecking received after the stipulated time will not be entertained . A copy of the answer sheet will be issued only once to a candidate. Candidates are prohibited from applying for copy of answer sheet which is not their own, and legal proceedings will be initiated against those who do so.

NOTE (3) :- "Any candidate can relinquish his right for appointment in writing duly attested by a Gazetted Officer of State/Central Government with signature, name, designation and Office Seal along with a notarized affidavit and a self attested copy of an ID proof bearing photograph as enlisted in the General Conditions". The request for relinquishment received within 15 days from the date of publication of Ranked List in the official website of the Commission will be honoured against the requisitions of vacancies that are pending with the Commission up to the finalization of ranked list. After the publication of the Ranked List, the request for relinquishment will be considered only if such request is received on or before the date of receipt of requisition, based on which he is to be advised."

NOTE (4) :- Valid applications for rechecking/ photocopy of answer script addressed to District Officer, K.P.S.C District Office, Wayanad shall reach this office within 45 days from the date on which the Ranked List is uploaded in the website . The last date for receipt of applications for rechecking/ photocopy of answer script is 19 .02.2022. Application for rechecking/ photocopy received after the prescribed time limit and not in the prescribed form will not be entertained.

NOTE (5) : Since a common Written Test/ OMR test with common candidates was conducted for this post, the marks awarded to the candidates included in this Ranked List and mark of OMR test relating to all candidates appeared for the test will be published only after the publication of entire Ranked Lists which will be finalized on the basis of the common test.

NOTE (6) :- The A part and B part of the OMR scripts will be destroyed after completing six months period from the date of finalization of the Ranked List ie, on 28/06/2022
