NOTIFICATION

The following is the list of candidates for selection to the post of **TRAINING INSTRUCTOR (DRAFTSMAN-CIVIL) (BY TRANSFER)** on **Rs.26500-56700/-** in **SCHEDULED CASTES DEVELOPMENT DEPARTMENT**, interviewed and found suitable by the Commission and arranged in the order of merit. This Ranked List is brought into force with effect from **22.02.2022**.

NOTE (1) :- The Ranked List will be in force till the publication of a new Ranked List after the expiry of a minimum period of one year or till the expiry of three years which ever is earlier. The rules of reservation and rotation are not applicable for this Ranked List and candidates will be advised on the basis of strict seniority assigned in the Ranked List. As the advice for appointment depends on the occurrence of vacancies, there is no guarantee that all candidates included in the list will secure appointment. The candidates remaining in the list at the time of cancellation will have no claim at all for appointment on the basis of the inclusion of their names in the list.

NOTE (2) :- Since a common Written Test/OMR Test with common candidates was conducted for this post, the marks awarded to candidates included in this Ranked List and mark of OMR test relating to all candidates appeared for the test will be published only after the publication of entire Ranked Lists (including NCA Notifications) which will be finalised on the basis of the common test.

NOTE (3) :- The result of rechecking of OMR answer scripts will be intimated in due course. But photocopy of the OMR answer scripts will be issued only after the publication of the Ranked Lists for all the posts finalised on the basis of the common test.

NOTE (4) :- According to the existing procedure, revaluation of Answer Script is not allowed. But Answer Scripts will be rechecked if the candidates apply for in the prescribed application form available free of cost from the Enquiry sections of the various offices of the Commission or its photocopy, or downloaded and printed form in A4 size paper from the Commission's Website www.keralapsc.gov.in or photocopied there from along with original chalan receipt for the prescribed fee of Rs.85/- (Rupees Eighty Five only) under the head of account "0051 - PSC 105 State PSC 99 – Examination Fee", addressed to The Deputy Secretary (Examinations), Kerala Public Service Commission Pattom, Thiruvananthapuram-4. Applications submitted in any other manner will not be considered. A period of forty five days time to apply for rechecking of Answer Scripts will be allowed to candidates with effect from the date of publication of the Ranked List in the official Website of the Commission (on or before 07.04.2022). Candidates can avail only one chance after the publication of Ranked list. Rechecking of invalidated answer script due to any defects will not be considered. Application for rechecking received after the stipulated time will not be entertained and fee once remitted will not be refunded.

NOTE (5) :- Candidates who wish to obtain a photocopy of their OMR answer sheet (Part A& Part B) relating to this selection shall remit the fee of Rs.335/- in any of the Treasuries in the State (Head of account: 0051 PSC-800-State PSC-99 other receipts). The duly filled in application in the prescribed form (available from the Commission's website www.keralapsc.gov.in) along with the original chalan should be submitted to **The Deputy Secretary (Examinations), Kerala Public Service Commission, Pattom, Thiruvananthapuram- 4** within 45 days from the date on which this Ranked List is uploaded in the commission's Website (on or before 07.04.2022). Copy of an answer sheet will be issued only once to a candidate. Copies of OMR answer sheets invalidated due to any defect will not be issued. Candidates are prohibited from applying for a copy of an answer sheet which is not their own, and legal proceedings will be initiated against those who do so.

NOTE (6) :- Any candidate can relinquish his/her right for appointment in writing duly attested by a Gazetted Officer of State/Central Government with signature, name, designation and office seal along with a notarized affidavit and a self attested copy of an ID Proof bearing photograph as enlisted in the General conditions. The request for relinquishment received within 15 days from the date of publication of Ranked List in the Official website of the Commission will be honoured against the requisitions of vacancies that are pending with the Commission upto the finalisation of Ranked List. After the publication of the Ranked List, the request for relinquishment will be considered only if such request is received on or before the date of receipt of requisition based on which he/she is to be advised.

NOTE (7) :- The A part and B part of OMR scripts will be destroyed after completing six months period from the date of finalisation of Ranked Lists included in the common test held on 24.09.2020.
