Note :- (6) SC /ST candidates included in the Probability List are required to produce Community Certificate in Form III / Digitally Signed Certificate and candidate belonging to other reservation groups are required to produce Non - Creamy Layer Certificate as per GO (P)No. 81/2009/SC/STDD dated. 26.09.2009 and EWS candidates are required to produce certificate issued by the concerned Revenue authority at the time of OTR verification.

Note :- (7) Copy of answer scripts of the OMR Test held on **31-07-2021** will be issued to those candidates who, apply for the same remitting the prescribed fee after approval of the Ranked List.
