Applications are invited from qualified Scheduled Tribe candidates of Kerala State for selection to the following post. Applications must be submitted online through the official website of the Commission after One Time Registration. Candidates who have already registered can apply through their profile.

- 1 Name of Department** : Collegiate Education  
**2 Name of post** : Assistant Professor in Mathematics  
(Special Recruitment from Scheduled Tribes Only)  
**3 Scale of pay** : UGC  
**4 No. of Vacancy** : 02 (Two)

**Note:-** The above Vacancies are now in existence. The Ranked list of selected candidates published by the Commission shall remain in force for a minimum period of one year and a maximum period of three years provided that the said list will not continue to be in force if a new list after the expiry of the minimum period of one year is published. Recruitment will be made for the above vacancy and also for the vacancies reported for Special Recruitment from Scheduled Tribes only during the currency of the list.

- 5 Method of Appointment** : Direct Recruitment (Special Recruitment from Scheduled Tribes only).

**Note:** Applications received from candidates other than Scheduled Tribe candidates will be rejected. Individual communications regarding the rejection of their applications for the above reason will not be issued.

- 6 Age:** : 22-45  
(Only Candidates born between 02.01.1977 and 01.01.2000(both dates included) are eligible to apply for this post).

**Note:** In the absence of qualified candidates within the age limit the upper age limit shall be relaxed up to 50years. But in no case the maximum age limit shall exceed 50 (Fifty ) years.

**Qualifications:-**

1. Master's Degree in Mathematics with atleast 50% marks or its equivalent and good academic record.
2. Must have passed a Comprehensive Test in the subject concerned specifically conducted for the purpose by UGC or any agency duly constituted by the State Government in this behalf. When qualification being equal preference shall be

given to those candidates who possess adequate knowledge in Malayalam.

**Note:-**

1) Candidates who have obtained Ph.D. Degree in Mathematics are exempted from passing the NET examination.(G.O.(P)No.86/07/H.Edn dated 19.06.2007)

2) For recruitment to this post degrees awarded by the Universities recognized by UGC alone shall be considered.

3) (a). Candidates who have acquired Non-qualifying degrees viz.Ph.D/M.Phil/Post Doctoral Fellowship will be awarded weightage marks provided that such non-qualifying degrees shall be in the subjects pertaining to the basic qualification stipulated for the post."Weightage marks for non qualifying degrees for ranking will be awarded as detailed below".

Non-Qualifying M.Phil - 2 marks

Non-Qualifying Ph.D- 4 marks

Both M.Phil & Ph.D (Non-Qualifying) -5 marks

Post Doctoral Fellowship - 2 marks

(b). Non-Qualifying degree means the additional qualifications which are earned apart from the qualifications insisted on as essential qualifications for the post. If Ph.D/M.Phil/Post Doctoral Fellowship is reckoned necessary qualification for the post,weightage marks will not be awarded for it.

- 4) Rule 10 (a) (ii) of Part II KS&SSR is applicable for this selection.
- 5) Those candidates who have claimed equivalency for qualifications should produce the Government order proving the same at the time of certificate verification in order to consider as equivalent.
- 6) If the caste of candidates is wrongly mentioned in their SSLC book, they should claim their original caste in their applications and should produce community certificate issued from concerned revenue authority and the Gazette Notification for the same at the time of certificate verification.

**8. Mode of Submitting application:**

(a) Candidates must register as per "ONE TIME REGISTRATION" system on the official Website of Kerala Public Service Commission '[www.keralapsc.gov.in](http://www.keralapsc.gov.in)' before applying for the post. Candidates who have registered can apply by logging on to their profile using their User-ID and password. Candidates must click on the 'Apply Now' button of the

respective posts in the Notification Link to apply for the post. The Photograph uploaded should be the one taken after 31.12.2012. Name of the candidate and the date of taking photograph should be printed at the bottom portion. No application fee is required. Candidates are responsible for the correctness of the personal information and secrecy of password. Before the final submission of the application on the profile, candidates must ensure correctness of the information on their profile. They must quote User-ID for further communication with the Commission. Application submitted is provisional and cannot be deleted or altered after submission. Candidates are advised to keep a printout or soft copy of the online application for future reference. Candidates can take the printout of the application by clicking on the link 'My applications' in their profile. All correspondences with the Commission, regarding the application should be accompanied with the print out of the application. The applications will be summarily rejected if non-compliance with the notification is found in due course of processing. Original documents to prove qualification, Experience, Community, Age etc. have to be produced as and when called for.

**(b)** Those who have Aadhaar Card should add Aadhaar Card as ID Proof in their profile.

**(c)** If written/OMR/Online Test is conducted as part of this selection, candidates shall submit a confirmation for writing the examination through their One Time Registration profile. Such candidates alone can generate and download the Admission Tickets in the last 15 days till the date of Test. The applications of candidates who do not submit confirmation within the stipulated period, will be rejected absolutely. The periods regarding the submission of confirmation and the availability of Admission Tickets will be published in the Examination Calendar itself. Information in this regard will be given to the candidates in their respective profiles and in the mobile phone number registered in it.

**(d)** Appropriate disciplinary action as per KPSC Rules of Procedure (1976) Rule 22 shall be initiated against those candidates who submit applications with bogus claims of qualification regarding education, experience etc. and submit confirmation for writing the examination, irrespective of whether they are present or absent for the examination.

**(e) Candidates who created the profile on or after 01.01.2022 should upload the photograph taken within 6 months .**
