SC/ST Candidates are required to produce Community Certificate issued by the Revenue authority at the time of OTR Verification.

Note :- (7) Copy of answer scripts of the OMR Test held on **17-08-2021** will be issued to those candidates who, apply for the same remitting the prescribed fee after approval of the Ranked List. Candidates whose Register Numbers are invalidated are advised to refer to Notification No : ERXV(2)4781/2021/EW dated 21-04-2022.
