Applications are invited from qualified **Scheduled Caste/Scheduled Tribe** candidates of Kerala State for selection to the following post. Applications must be submitted online through the official website of the Kerala Public Service Commission after one time registration. Candidates who have already registered can apply through their profile.

1. Department	: Higher Secondary Education
2. Name of post	: Laboratory Assistant (Special Recruitment for SC/ST)
3. Scale of pay	: ₹. 24,400 – 55,200/-
4. Number of Vacancies	: District wise

- Thiruvananthapuram 02 (SC/ST) Kollam – 01 (SC/ST) Kannur – 02 (SC/ST)
- Notes: i) Separate Ranked Lists will be prepared for the above districts in pursuance of this notification. The Ranked List thus prepared and published by the Commission in response to this notification shall remain in force for a minimum period of one year provided that the said list will continue to be in force till the publication of a new list after the expiry of the minimum period of one year or till the expiry of three years whichever is earlier. *Recruitment will be made for the above vacancies and also for the vacancies reported for Special Recruitment from Scheduled castes/Scheduled Tribes during the currency of the list. Candidates shall also be advised from this list against vacancies reported exclusively for Scheduled Tribes and only in the absence of Scheduled Tribes will be issued for vacancies reserved exclusively for them.*

- ii) The selection in pursuance of this notification will be made on a revenue district basis, subject to the special conditions laid down in G.O. (Ms) No. 154/71/PD dated, 27.05.1971. A candidate advised for appointment in one revenue district from the Ranked List so prepared is not eligible for transfer to another district unless he/she completes five years continuous service from the date of commencement of service in the former district. Even if, transfer is allowed after five years, it will be subject to the orders contained in G.O(MS) No. 4/61/PD, dated 02.1.1961. Candidates already in Government service, holding the post in any one district are restricted from applying for the same post in another district. But they can apply for higher posts when notified.
- iii) Applications should only be sent to the particular District in response to this notification. If applications are sent contrary to the above direction and if he/she is selected, his/her name will be removed from the Ranked List and disciplinary action will be taken against him/her. Candidates should submit application for the post to the district office concerned, where the vacancy is existing and should note the name of that district against the relevant column of the online application.
- iv) In case of change in caste noted in the SSLC book, candidates must claim their original caste in the application and shall produce Community Certificate issued by the Revenue authorities and the original Gazette Notification publishing the change of caste at the time of OTR verification for selection to the above post.
- 5. Method of appointment : Direct Recruitment (Special Recruitment from among Scheduled Caste/Scheduled Tribes)

<u>Note</u> : Applications received from candidates other than Scheduled Caste/Scheduled Tribe will be rejected. Individual communications regarding the rejection of their applications for the above reason will not be issued.

6. Age : 18-41. Only Candidates born between 02.01.1981 and 01.01.2004 (both dates included) are eligible to apply for this post.

Note :- In the absence of qualified candidates within the age limit the upper age limit shall be relaxed upto 50 years. But in no case the maximum age limit shall exceed 50 (fifty) years.

# 7. **Qualifications :-**

(1) Pass in SSLC examination.

(2) Pass in Laboratory Attenders Test conducted by the Kerala Public Service Commission.

Note :- Pass in Laboratory Attender's Test is not compulsory at the time of appointment. Candidates should pass the test during the period of probation.

Note: Rule 10 a (ii) of Part II KS & SSR is applicable for selection to this post. Candidates claiming higher/equivalent to the qualification for which equivalency is prescribed in the notification should produce the relevant Government Order to prove the equivalency at the time of verification, then only such qualification shall be treated as equivalent to the prescribed qualification concerned.

# 8 Mode of submitting application:-

(a) Candidates must register as per ONE TIME REGISTRATION with the Kerala official website of Public Service Commission www.keralapsc.gov.in before applying for the post. Candidates who have registered can apply by logging on to their profile using their User-ID and Candidates must click on the 'Apply Now' button of the Password. respective posts in the Notification Link to apply for a post. The photograph uploaded should be taken after 31.12.2012. In the case of candidates who are creating a new profile the uploaded photograph must be taken within 6 months. Name of the candidate and the date of photograph taken should be printed legibly at the bottom portion. The photograph once uploaded meeting all requirements shall be valid for 10 years from the date of taking the photograph. There is no change in other instructions regarding the uploading of photographs. No application fee is required. Candidates are responsible for the correctness of the personal information and secrecy of password. Before the final submission of the application on the profile candidates must ensure correctness of the information in their profile. They must quote the User-ID for further communication with the Commission. Application submitted is provisional and cannot be deleted or altered after submission. Candidates are advised to keep a printout or soft copy of the online application for future reference. Candidates can take the printout of the application by clicking on the link 'My applications' in their profile. All correspondences with the Commission, regarding the application should be accompanied with the print out of the application. The will be summarily rejected if noncompliance with the application notification is found in due course of processing. Original documents to prove qualification, age, community etc. have to be produced as and when called for.

(b) Candidates who have Aadhaar card should add Aadhaar card as I.D proof in their profile.

- 9 Last date for submission of application :01.06.2022 Wednesday up to 12 midnight.
- 10 If a Written/OMR/Online Test is conducted as part of this selection,

candidate shall submit a confirmation for writing the examination through their One Time Registration Profile. Such candidate alone can generate and download the admission tickets in the last 15 days till the date of test. The application of candidates who do not submit confirmation within the stipulated period will be rejected absolutely. The periods regarding the submission of confirmation and the availability of admission tickets will be published in the examination calendar itself. Information in this regard will be given to the candidates in their respective profiles and in the mobile phone number registered in it. Candidates who have downloaded the Admission Ticket will alone be permitted to attend the examination.

- 11 Appropriate disciplinary action as per Rule 22 of the KPSC Rules of Procedure 1976 shall be initiated against those candidates who submit application with bogus claims of qualification regarding education, experience etc and submit confirmation for writing the examination, irrespective of whether they are present or absent for the examination.
- 12 Paragraphs two, three and twenty five (except the conditions laid down in Rule 3 (c), Part II of the Kerala State and Subordinate Service Rules) are not applicable to this selection.
- 13 Appointments are made on the basis of the rank secured in the ranked list of candidates prepared in pursuance of this notification subject to the conditions laid down in G.O (P) No. 21/76/PD dated, 17.01.1976 and G.O (P) No. 25/94/GAD dated, 22.01.1994 allowing special reservations to Scheduled Tribes in accordance with the procedures made for this purpose from time to time and subject to the rules under sections 3(c), 17(a), 17(b) of Part II of Kerala State and Subordinate Service Rules, 1958.
