3% of vacancies for the post shall be reserved for Differently abled candidates with Locomotor Disability/Cerebral palsy as per G.O(P)No. 61/12/SWD dated 17.10.2012. Differently Abled candidates having disability other than the above are not eligible to apply for this post.

7. Qualifications:-

- **1.** M.D (Ayurveda) Marma/Salya awarded by a recognized University.
- 2. 'A' class Registration in the Travancore-Cochin Medical Council.

Note:- 1. KS & SSR Part II Rule 10(a)(ii) is applicable.

- **2.** Candidates who claim equivalent qualification instead of qualification mentioned in the notification shall produce the relevant Government Order to prove the equivalency at the time of the verification, then only such qualification shall be treated as equivalent to the prescribed qualification concerned.
- **3.** In the case of difference in original Caste/Community claimed in the application and that entered in S.S.L.C book, the candidate shall produce a Gazette notification in this regard, along with Non Creamy Layer Certificate/Community Certificate at the time of certificate verification.
- **8. Probation:-** Every person appointed to this post shall from the date on which he joins duty be on probation for a period of two years on duty within a continuous period of three years.

9. Mode of submitting Application:-

No application fee is required. Candidates shall take a printout of the application by clicking the link 'My applications' in the profile. Candidates are responsible for the correctness of the personal information and secrecy of password. Before the final submission of the application on the profile candidates must ensure correctness of the information in their profile. They must quote the User-ID for further communication with the Commission. Application submitted is provisional and cannot be deleted or altered after submission. The application will be summarily rejected if non-compliance with the notification is found in due course of processing. Original documents to prove qualification, experience, age, community etc. have to be produced as and when called for.
- **(b)** If written/OMR/Online Test is conducted as part of this selection, candidates shall submit a confirmation for writing the examination through their One Time Registration Profile. Such candidates alone can generate and download the

Admission Tickets in the last 15 days till the date of Test. The applications of candidates who do not submit confirmation within the stipulated period, will be rejected absolutely. The periods regarding the submission of confirmation and the availability of Admission Tickets will be published in the Examination Calendar itself. Information in this regard will be given to the candidates in their respective profiles and in the mobile phone number registered in it.
