The minimum marks for inclusion in the list of candidates belonging to ST communities have been lowered to ensure their adequate representation in the eligibility list. The marks secured in the Common Preliminary Examination Degree level by the candidate will be considered only for ascertaining the eligibility to appear for the final exam and will not be considered for the purpose of final ranking and shall not have any relevance while preparing the Rank List for the post.

Note 5. If any of the documents produced by any candidate is found defective the Commission reserves the right for rejection of their candidature at any stage of selection as per rule.

Note 6. According to the existing procedure, revaluation of Answer Script is not allowed. But Answer Scripts will be rechecked if the candidates apply in the prescribed form available free of cost from the Enquiry Sections of the various Offices of the Commission or its photocopy, or downloaded and printed in A 4 size paper from the Commission's website www.keralapsc.gov.in or photocopied along with prescribed fee of Rs. 85/- (Rupees Eighty Five Only) under the Head of Account "0051 - PSC - 105 State PSC 99 -Examination Fee". Such applications should reach the Deputy Secretary (Examinations)-III, Kerala Public Service Commission, Pattom P.O., Thiruvananthapuram - 695004 on or before 30/07/2022 ie., within 15 (Fifteen) days from the date on which this Eligibility List is uploaded in the website of the Commission. Applications submitted in any other manner will not be considered. The candidates can avail only one chance for rechecking after the Approval of Eligibility List within the time limit fixed above.
