Applications are invited online only through One Time Registration from qualified candidates for appointment in the undermentioned post in Kerala Government Service. Before applying for the post, candidates should register as per One Time Registration through the official website of the Kerala Public Service Commission. The candidates who have already registered can apply through their profile.

- 1 **Department** : Kerala General Education (DIET)
- 2 **Name of Post** : Lecturer in Foundations of Education and Action Research
- 3 **Scale of pay** : ₹ 55200 – 115300/-
- 4 **Number of vacancies** : 03 (Three)

The above vacancies are now in existence. The Ranked List published by the Commission in response to this notification shall remain in force for a minimum period of one year provided that the said list will continue to be in force till the publication of a new list after the expiry of the minimum period of one year or till the expiry of three years whichever is earlier. Candidates will be advised from the said list against the aforesaid vacancies and the vacancies reported to the Commission during the period of the currency of the list.

- 5 **Method of appointment** : By-Transfer Recruitment

Note:-

1. In the case of appointments by transfer, a ratio 2:1 shall be maintained from the Following two units, namely:
 - i) Appointed as Teachers in Government Primary School and continuing service as a Teacher
 - ii) Appointed as Teachers in Government Higher Secondary School, Vocational Higher Secondary School, High School and Teacher Educators in the Institutes of Teacher Education and continuing service as a Teacher
2. If qualified hands are not available in item number (i) of Note 1 above, the vacancies shall be filled up from item (ii) and *vice versa*. In the absence of qualified hands in both items (i) and (ii) above, the vacancies shall be filled up by direct recruitment.

3. Candidates who apply for By-Transfer recruitment should obtain a service certificate in original in the form mentioned below from the Head of institution in which they are working as Government Primary School/ High School/ Higher Secondary School/ Vocational Higher Secondary School Teachers or Teacher Educators in the Institutes of Teacher Education. They shall produce the same as and when required by the Commission.

Note:-The genuineness of the certificate will be subjected to verification and if found bogus, legal action will be taken against the authorities who issued bogus certificate and the candidates who produce the same.

6 Age limit : Upper age limit for appointment by transfer shall be 50 years as on the first day of January 2022 .

7 Qualifications :

- 1) Masters Degree with not less than 50% marks under the faculty of Humanities, Science, Commerce or languages from any statutory University established in India .
- 2) M.Ed Degree with not less than 50% marks with specialization in Foundations of Education or Educational Psychology or Research Methodology from any statutory University established in India.
- 3) Not less than three years regular teaching service as Teacher Educators in Teacher Training Institutes under the Government or as Primary Department Teacher or as High School Teacher or as Higher Secondary School Teacher or as Vocational Higher Secondary School Teacher in the Government Schools in Kerala.

Note:- Postgraduate Degree (MA) in Education with specialization in any subject specified in item (2) thereto with B.Ed or B.El.Ed in any subject shall be equivalent to qualifications specified in items (1) and (2) above.

Note:-

1) Candidates who have acquired Non-qualifying degrees viz. Ph.D/M.Phil/Post Doctoral Fellowship will be awarded weightage marks provided that such non-qualifying degrees shall be in the subjects pertaining to the basic qualification stipulated for the post. Weightage marks for non qualifying degrees for ranking will be awarded as detailed below.

Non-Qualifying M.Phil - 2 marks

Non-Qualifying Ph.D- 4 marks

Both M.Phil & Ph.D (Non-Qualifying) -5 marks

Post Doctoral Fellowship - 2 marks

2) Non-Qualifying degree means the additional qualifications which are earned apart from the qualifications insisted on as essential qualifications for the post. If Ph.D/M.Phil/Post Doctoral Fellowship is reckoned as necessary qualification for the post,weightage marks will not be awarded for it.

3) Weightage marks will be awarded only to those non-qualifying degrees which are claimed in the application and which are acquired on or before the last date for receipt of application.

4)Rule 10 a (ii) of part II of KS&SSR is applicable.

5)The Degrees / Diplomas awarded by UGC approved Universities or Institutions established through an act passed by the Parliament/State Legislative Assembly in accordance with the condition laid down in G.O (M.S) No.526/PD dated 17/07/1965 are acceptable for appointment in Government Services.

6)Candidates who claim equivalent Qualification instead of qualification mentioned in the notification shall produce the relevant Government order to prove the equivalency at the time of certificate verification, then only such qualification shall be treated as equivalent to the prescribed qualification .

Reservation:-

Rules of reservation provided under rules 14 to 17 of part II of KS & SSR 1958 are not applicable for By – Transfer Recruitment.

8 Mode of Submitting applications

- a) Candidates must register as per “ONE TIME REGISTRATION” with the official Website of Kerala Public Service Commission 'www.keralapsc.gov.in' before applying for the post. Candidates who have registered can apply by logging on to their profile using their User-ID and password. **Candidates must click on the 'Apply Now' button of the respective posts in the Notification Link to apply for the post. The Photograph uploaded should be the one taken after 31.12.2012.** Name of the candidate and the date of taking photograph should be printed legibly at the bottom portion. The photograph once uploaded meeting all requirements shall be valid for 10 years from the date of uploading. **Candidates who have created new profile on or after 01.01.2022 shall upload photograph taken within six months.** There is no change in other instructions regarding the uploading of photographs .No application fee is required. **Candidates shall take a printout of the application by clicking the link 'My applications' in their profile.** All correspondence with the Commission regarding the application should be accompanied with the printout of the application. Candidates are responsible for the correctness of the personal information and secrecy of password. Before the final submission of the application on the profile, candidates must ensure correctness of the information on their profile. **They must quote User-ID for further communication with the Commission.** Application once submitted is received as provisional and the details cannot be deleted or altered after last date of receipt of applications. The application will be summarily rejected if non-compliance with the notification is found in due course of processing. Documents to prove qualification, Experience,Community,Age, etc. have to be produced as and when called for. The profile correction made by the candidates themselves or through the office of the KPSC on request after the last date fixed for the receipt of applications will not be reflected in the application. Such corrections will come into effect only on the date on which corrections have been made.
- b) If a Written/OMR/Online Test is conducted as part of this selection,candidates shall submit a confirmation on writing the examination through their one time registration profile. Such candidates alone can generate and download the admission tickets in the last 15 days till the date of test. The application of the candidates who do not submit confirmation within the stipulated period will be rejected summarily. The periods regarding the submission of confirmation and

availability of admission tickets will be published in the examination calender itself. Information in this regard will be given to the candidates in their respective profiles and the mobile phone number registered in it.

- c) Appropriate disciplinary action as per KPSC Rules of Procedure Rule 22 shall be initiated against those candidates who submit applications with bogus claims of qualification regarding education, experience etc. and submit confirmation for writing the examination, irrespective of whether they are present or absent for the examination.

- d) Candidates who have AADHAAR card should add AADHAAR Card as I.D Proof in their profile.
