Note(7).Copy of answer scripts of the OMR Test held on **20-03-2022** will be issued to those candidates who, apply for the same remitting the prescribed fee after approval of the Ranked List. No answerscripts of candidates who appeared for the OMR test have been invalidated for selection to this post.
