Applications are invited from qualified **Scheduled Tribe** candidates of Kerala State for selection to the following post. Applications must be submitted online through the official website of the Kerala Public Service Commission after One Time Registration. Candidates who have already registered can apply through their profile. **Candidates who have AADHAR card should add AADHAR as ID proof in their profile.**

- 1 Name of Department** : AYURVEDA MEDICAL EDUCATION
- 2 Name of post** : ASSISTANT PROFESSOR IN VARIOUS SUBJECTS  
(Special Recruitment for ST only)
- 3 Scale of pay** : ₹15600-39100/- AGP 6000 (UGC)

**Note:** The above Vacancies are now in existence. The Ranked list of selected candidates published by the Commission shall remain in force for a minimum period of one year and a maximum period of three years provided that the said list will not continue to be in force if a new list after the expiry of the minimum period of one year is published for this post under the same method of appointment. Advice for appointment will be made for the above vacancy and also for the vacancies reported exclusively for Scheduled Tribes during the pendency of the list.

- 5 Method of Appointment** : Direct Recruitment (Special Recruitment for Scheduled Tribes only).

**Note:-** Applications received from candidates other than Scheduled Tribe candidates will be rejected. Individual communications regarding the rejection of their applications for the above reason will not be issued.

- 6 Age** : 20-50,  
Only Candidates born between 02.01.1972 and 01.01.2002 (both dates included) are eligible to apply for this post. No other age relaxation will be allowed.

**7 Qualifications:**

- (i) A Post Graduate Degree in Ayurveda in the concerned subject from any of the Universities in Kerala or from any other University recognised by any of the Universities in Kerala.
- (ii) Permanent 'A' Class Registration with Travancore – Cochin Medical Council (Council of Indigenous Medicine).

**Note:-** 1 Post graduate degree in the concerned subject has been made compulsory for appointment by direct recruitment to the post of Assistant Professor.

- 2 If post-graduate holders of any subject are not available, post-graduate qualifications prescribed by Central Council of Indian Medicine shall be admissible for that subject from time to time.

- 3 Rule 10(a)(ii) of part II of KS&SSR is applicable.
- 4 In addition to the qualifications specified in this notification, the qualifications declared by the Government to be equivalent to the prescribed educational qualifications through executive orders or standing orders, and higher qualifications with the prescribed qualifications as the basic qualifications shall be accepted. The Government orders regarding the equivalent qualification/higher qualification shall be produced as and when called for by the Commission.
- 5 If the caste of the candidate is wrongly mentioned in their SSLC book, they should claim their original caste in their applications and should produce community certificate issued from the revenue authority concerned and the Gazette Notification to prove the same at the time of certificate verification.

**8 Probation:**

Every Person appointed to this post shall from the date on which he joins duty be on Probation for a total period of two years on duty within a continuous period of three years.

**9 Mode of Submitting application:**

Candidates must register as per ONE TIME REGISTRATION with the official Website of Kerala Public Service Commission [www.keralapsc.gov.in](http://www.keralapsc.gov.in) before applying for the post. Candidates who have registered can apply by logging on to their profile using their User-ID and Password. Candidates must click on the 'Apply Now' button of the respective posts in the Notification Link to apply for a post. Name of the candidate and the date of photograph taken should be printed legibly at the bottom portion of the photograph uploaded. **Candidates who create their profile from 01/01/2022 should upload their photograph taken within the period of six months** The photograph once uploaded meeting all requirements shall be valid for 10 years from the date of taking of photographs. There is no change in other instructions regarding the uploading of photographs. No application fee is required. Candidates are responsible for the correctness of the personal information and secrecy of password. Prior to the final submission of the application on the profile candidates must ensure correctness of the information incorporated in their profile. They must quote the User-ID for further communication with the Commission. Application submitted is provisionally accepted and cannot be deleted or altered after submission. **Candidates are advised to keep a printout or soft copy of the online application for future reference. Candidates can take the printout of the application by clicking on the link 'My applications' in their profile. All correspondences with the Commission, regarding the application should be accompanied with the print out of the application.** The application will be summarily rejected if non-compliance with the notification is found in due course of processing. Original documents to prove qualification, experience, age, Community etc. have to be produced as and when called for.

- 12 Paragraphs two, three and twenty five (except the conditions laid down in the Rule 3 (C) of Part II of the Kerala State and Subordinate Service Rules) are not applicable to this selection.
- 13 Appointment are made on the basis of the rank secured in the ranked list of candidates prepared in pursuance of this notification subject to the conditions laid down in G.O.(P) No. 21/76/PD dated, 17.01.1976 and G.O.(P) No.25/94/GAD dated, 22.01.1994 allowing special reservations to Scheduled Tribes in accordance with the procedures made for this purpose from time to time and subject to the rules under sections 3(c), 17(A), 17(B) of Part II of Kerala State and Subordinate Service Rules, 1958.
- 14 If written/OMR/Online Test is conducted as part of this selection, candidates shall submit a confirmation for writing the examination through their One Time Registration profile . Such candidates alone can generate and download the Admission Tickets in the last 15 days till the date of Test. The applications of candidates who do not submit confirmation within the stipulated period, will be rejected absolutely. The period regarding the submission of confirmation and the availability of Admission Tickets will be published in the Examination Calendar itself. Information in this regard will be given to the candidates in their respective profiles and in the mobile phone number registered in it.

- 15** As per Rule 22 of the Kerala Public Service Commission Rules of Procedure candidates who make false claims about qualifications such as education, experience etc., *and submit confirmation for writing the examination, irrespective of whether they are present or absent for the examination are liable to be* disqualified for being considered for any post they are applying for, or debarment from applying to the commission either permanently or for a particular period or invalidation of answer scripts in the written examination or products in a practical test attended by them or initiations of legal action against them or removal or dismissal from the office or the ordering of any disciplinary/legal action against them if they have been appointed on or any one more of the above actions against them.
