NOTE (4):-"Valid applications for Rechecking /obtaining photocopy of answer script, in the precribed format downloaded from the official website of the Public Service Commission, addressed to the Deputy Secretary (Exams), KPSC,Pattom,Thiruvananthapuram-4 shall reach the office within 30 days from the date on which the Ranked List has uploaded in the official website of the Commission. The last date for receipt of applications for rechecking /obtaining photocopy of the answer script is 02.02.2023.Applications for rechecking /obtaining photocopy, received after the prescribed time limit and not in the prescribed form will not be entertained."

NOTE (5):- The entries put in column (8) are based on the Communities specified by the candidate in their Application forms and proved by them with necessary documents.
