Note:- (4) Candidates included in the Probability List should present and produce in person the original documents for One Time Verification. **Date,time and Venue of OTR Verification will be published shortly.**

Note:- (5)The register number of those candidates who do not produce the required documents within the prescribed time limit and whose applications found other wise defective will be deleted from the Probability List with out further notice.

Note:- (6) According to the existing procedure, revaluation of answer scripts is not allowed but answer scripts can be rechecked after the publication of Ranked List. Detailed instructions will be published in the Ranked List to be published for the post.

Note :- (6) Candidates belonging to SC/ST Community included in the Probability List are required to produce Community Certificate issued by the Revenue authority at the time of OTR Verification.Candidates belonging to other backward classes included in the Probability List are required to produce Non Creamy Layer Certificate as per G.O.(P)No.81/09/SC/ST/DD dated 26/09/2009 and candidates belonging to EWS should produce relevant certificate asper GO(MS) No.2/2020/P&ARD dated 12/02/2020 in proof of their claim along with other documents mentioned at the time of OTR Verification.

Note :- (7) Copy of answer scripts of the OMR Test held on **07-05-2022** will be issued to those candidates who apply for the same remitting the prescribed fee after approval of the Ranked List. Candidates whose Register Numbers are invalidated are advised to refer to Notification No : ERII(1)2749/2022/EW Dated 31/10/2022.
