#### **NOTIFICATION**

The following is the list of candidates for selection to the post of **AGRICULTURAL OFFICER - I NCA SCCC** on Rs. **55,200-1,15,300/-** in **AGRICULTURE DEVELOPMENT AND FARMERS' WELFARE DEPARTMENT (CAT.NO.522/2021)** , interviewed and found suitable by the Commission and arranged in the order of merit for recruitment against NCA vacancies for SCCC community only . This Ranked List is brought into force with effect from 23.02.2023 and will be valid until candidates are advised and appointed against the vacancies earmarked for the above community but remains unfilled due to the paucity of candidates during the currency of the Mother Ranked List published on 24/07/2017 (Cat.No.271/2014) for the post.

NOTE (1) :-Since a common OMR Test with common candidates was conducted for this post, the marks awarded to candidates included in this Ranked List and mark of OMR test relating to all candidates appeared for the test will be published only after the publication of entire Ranked Lists (including NCA Notifications) which will be finalised on the basis of the common test.

NOTE (2) :-The result of rechecking of OMR answer scripts will be intimated in due course. But photocopy of the OMR answer scripts will be issued only after the publication of the Ranked Lists for all the posts finalised on the basis of the common test.

NOTE (3) :- According to the existing procedure, revaluation of Answer Script is not allowed. But Answer Scripts will be rechecked if the candidates apply for in the prescribed application form available free of cost from the Enquiry Sections of the various Offices of the Commission or its photocopy, or downloaded and printed in A 4 size paper from the Commission's website [www.keralapsc.gov.in](http://www.keralapsc.gov.in) or Photocopied there from along with prescribed fee of Rs. 85/- (Rupees Eighty Five Only) under the Head of Account 0051 - PSC - 105 State PSC 99 - Examination Fee addressed to the Deputy Secretary (Examinations), Kerala Public Service Commission, Pattom P.O., Thiruvananthapuram-695004. Applications submitted in any other manner will not be considered. A period of 30 (Thirty) days time to apply for rechecking of Answer Scripts will be allowed to candidates with effect from the date of publication of the Ranked List in the official Website of the Commission (on or before 25.03.2023). The candidates can avail only one chance after the approval of Ranked List. Rechecking of invalidated answer scripts due to any defects will not be considered. Application for Rechecking received after the stipulated time will not be entertained and Fee once remitted will not be refunded.

NOTE (4) :- Candidates who wish to obtain a photocopy of their OMR Answer Sheets (Part A & Part B) relating to this selection shall remit a Fee of Rs. 335/- (Rupees Three Hundred and Thirty Five only) in any of the Treasuries in the State (Head of Account : 0051 - PSC - 800 - State PSC -99-Other Receipts). The duly filled in application in the prescribed form available from the Commission's website [www.keralapsc.gov.in](http://www.keralapsc.gov.in) along with the original chalan should be submitted to the Deputy Secretary (Examinations), Kerala Public Service Commission, Pattom P.O., Thiruvananthapuram- 695004 within 30 (Thirty) days from the date on which this Ranked List is uploaded in the Commission's Website. A copy of an answer sheet will be issued only once to a candidate. Copies of OMR answer sheets invalidated due to any defect will not be issued. Candidates are prohibited from applying for copy of an answer sheet which is not their own, and legal proceedings will be initiated against those who do so. The last date for receipt of applications is 25.03.2023. Applications received after the prescribed date will not be entertained.

NOTE (5) :-Candidates who wish to relinquish their claim for advice from the Ranked List shall submit an application in the format prescribed by the Commission to THE SECRETARY, KERALA PUBLIC SERVICE COMMISSION HEAD OFFICE, PATTOM, THIRUVANANTHAPURAM-4. The format is available in the official website of the Commission. The request for relinquishment in respect of those who do not submit the relinquishment application in the format prescribed by the Commission will not be honoured under any circumstances. The request for relinquishment in the prescribed format should be duly attested by a Gazetted Officer of State/Central Government with signature, name, designation and office seal along with a Notarized Affidavit and a self attested copy of an ID Proof bearing photograph as enlisted in the General Conditions. The request for relinquishment along with the original of notarized affidavit and self attested copy of the ID Proof received within 15 days from the date of publication of Ranked List in the Official Website of the Commission will be honoured against the requisitions of vacancies that are pending with the Commission up to the finalisation of the Ranked List. After the publication of Ranked List, the request for relinquishment will be considered only if such requisite received on or before the date of receipt of vacancy, based on which he/she is to be advised.

NOTE (6) :- The A part and B part of OMR scripts will be destroyed after completing six months period from the date of finalisation of Ranked Lists included in the common test held on 26.03.2022.
